If a taxpayer was interested in the artificial turf soccer field proposed in El Dorado Park, I doubt they would realize it was a topic on the City Council agenda had it not been for the research and publication done by LB Report. <a href="https://www.lbreport.com/news/feb20/eldosoc3.htm">https://www.lbreport.com/news/feb20/eldosoc3.htm</a>

Pros and Cons of the artificial turf soccer field are summarized below:

THE UPSIDE: The American Youth Soccer Organization (AYSO) contractor that currently rents the space desires it be installed (at taxpayer expense) because:

- It allows schedule and play year round without having to shut down the field to repair natural grass.
- They can charge more for its use and when they don't have enough youth games to utilize the field, they can subcontract it out to adult teams and teams from surrounding cities.
- It increases the business potential/profit for use of the area.
- There are claims that it will take less water, (but that seems questionable based on the need to hose off the sweat and body fluids deposited on the field as well as wildlife excrement).

THE DOWNSIDE: 6 years ago, the artificial turf soccer field was proposed and encountered significant opposition from the neighborhood along Spring and Palo Verde causing the project to be scrapped. Objections include:

- Night lighting (current plan is to install the electrical but not install the poles?)
- Adult night soccer games that disturb neighbors
- Overload parking along Studebaker
- Noise pollution
- Replacement costs at end of product life (10 years) are exorbitant
- Loss of open space (the field is currently used by families during the summer concerts in the park as well as dog walking, throwing a football, games etc)
- The plastic fake grass is extremely hot in the summer and kids complain they can feel it through their shoes. It cannot be cooled down by water
- Kids complain it is slippery and results in more falls and injuries.
- Wildlife don't recognize it as not being grass and birds and wildlife defecate on it
- Sweat and body fluids need to be hosed off with each use.
- Disposal of a huge field of plastic is environmentally a problem, not to mention the cost.
- Maintenance costs not known or included in the proposal

CONCERN: This project went onto the Parks Commission agenda just 2 days before the meeting and almost no one knew the proposal had been resurrected. Is there a reason the public is being excluded and meetings are not being held on this project?

VISION: There seems to be a move afoot to commercialize park space. A recent RFP invites businesses to propose uses in El Dorado Park to bring in capital for the General Fund. The artificial turf soccer field appears to be a part of that vision, however, the neighborhood and the public have not been invited into the visioning of commercializing the park. A neighborhood leader posted a survey on nextdoor asking for support to "save the park" and there are thousands of signatures already captured. See attachment "Jill Brennan's letter on commercializing the park."

My personal objections to this project are both environmental (lack of sustainability with the product) and the costs. I believe there needs to be research and benchmarking done with other parks that have installed this product. We need to understand maintenance requirements and costs. Also see "competing needs" below.

COMPETING NEEDS: There are far more critical needs for \$1.5M in El Dorado Park. See attached Powerpoint and excel files with photos of work done by the Friends of El Dorado Park East group to communicate park needs. There are significant areas of non-ADA compliance and dangerous conditions that welcome a lawsuit. If we have extra Measure A money, we should be using it on the basic deferred maintenance in the park. There is also a plan to put in new playground equipment for \$450K that is a "nice to have" but not necessary. A review of existing playground equipment finds it in good repair, but needing paint. It is nowhere to be found on the extensive list of projects documented by Friends of El Dorado Park East on the attached excel file.

LACK OF OUTREACH: No meetings have been held on this project in over 6 years. The meetings that were held 6 years ago resulted in the defeat of the project. Resurrecting it, slipping it through the Parks Commission, attempting to discuss it at Council without making it clear what is on the agenda have the effect of disrespecting stakeholders.

MISUSE OF MEASURE A FUNDS: Using \$1.5M of measure A funds on something the neighborhood objects to violates the public trust and intention of Measure A.





#### Dear Councilmember Supernaw,

Thank you for posting the article regarding the proposed El Dorado Regional Park concessions on your Friday updates. Oh how we all wish El Dorado Regional Park was in the 4th District, as is the Nature Center.

As a former member of the LB Sustainability Commission(2008-2014) and serving with you on that Commission, I have the utmost respect for your ethics and integrity, your understanding of Sustainability, and your appreciation of the value of preserving open space and of the very unique and precious entity of El Dorado Regional Park, once considered the "Jewel of Long Beach". Sadly, through budget cuts and questionable maintenance practices, this Park has fallen into disrepair with broken roads, broken and unhealthy ponds, broken and unsafe sidewalks, broken and unsafe turf, broken restrooms, broken and unsafe picnic spaces, broken trees, and broken wildlife. It is visited by at least a million people each year per PRM reports, hosts several special events with thousands attending, and is a very frequent site for filming companies. NONE of the revenue from these uses and at times abuses of the Park go back to the Park for improvements. Former 5th District Councilmember Gerrie Shipske fought to have Park use revenues return to the Park for upkeep, maintenance, and to improve the safety, appearance, and enjoyment of this "Jewel" but was not able to make this change.

Now we have a push to "develop" this Park with the promise of a return of revenues to the Park. That is an empty promise. In the past year, a concessionaire, Eldorado Frontier, was allowed to begin to develop a corner of the Regional Park in Area 3 N of Wardlow with no rent and no return of any revenues for 5 years. He has built a high, ugly wood fence which prohibits the public from enjoying this once beautiful corner and disturbed essential wildlife habitat. PRM has spent thousands of dollars in putting in water and sewer lines, added extra maintenance costs, and just this month spent nearly \$25,000 to purchase 40 picnic tables for the exclusive use of Eldorado Frontier guests, and he has taken over a huge chunk of formerly public land for his private, pricey rental use of these tables and land for picnics.

This seems to be a gift of public land and public monies to a private for profit entity. I believe this is illegal. Now to see another attempt to further commercialize the Park and gift public land to a private entity is frightening. This Economic Development Department proposal was done behind closed doors on short notice during the holiday season and only 1 day public notice before the RFP was closed. I hear that many PRM departments were totally unaware of these dealings and were not consulted about the impacts on their staff with such development. The published map of the proposal which was shown in the LB Post and Acting PRM Director's response has a major error in locations and failed to mention that the Old Ranger Station has not been used for several years due to black mold. How much will the City pay to remedy that very costly remediation to then allow a for profit entity to move in and grab more public land and increase public maintenance costs for their exclusive use.

El Dorado Regional Park is unique and priceless in its beauty and open space and is loved for those reasons and as a respite from busy, noisy urban pressures. It is enjoyed by patrons from every Council District in Long Beach and many surrounding communities.

I urge you to go to <a href="www.change.org/SaveEldoradoPark">www.change.org/SaveEldoradoPark</a> to view the nearly 10,000 signed petitions to save this Park and see all the reasons the public treasures this very special place. I hope you will educate and lead the City Council in preserving this precious public City asset. Work to use Measure A funds to improve the safety and health of this Park for the public to enjoy. Work to return all the current revenue that this Park creates now back to the Park, not to the General Fund. Budget appropriately to properly fund and maintain this Park for the public to enjoy. This Park does not need private-for-profit "development". Contrary to Acting PRM Director Scott's comments, open green space already has been lost to public use by the Eldorado Frontier development. Where folks once could bring a picnic and enjoy a day in the Park, they now have to pay to use the picnic tables and grassy areas in the "development" areas.

#### **Dear Commissioners:**

El Dorado Regional Park, which is heavily used by residents of all council districts and many surrounding communities in LA and Orange counties, is suffering with broken roads, broken ponds, broken sidewalks, broken water pumps, broken irrigation systems, broken restrooms, and broken turf areas. Repeatedly, concerned citizens and park patrons are told there is no money to repair or restore any of these broken and unsafe Park assets. Yet, \$850,000 from Measure A funds and \$617,478.42 from Council one-time funds may be spent for 1 unsafe, high maintenance, high water use, unsustainable artificial turf soccer field in El Dorado Park West?

Where are the Parks and Recreation Commission priorities? Who is managing the Measure A funds? Why is the once "Jewel of Long Beach" El Dorado Regional Park being forgotten?

Councilmembers: I urge each of you to use this one time ~\$68,609 per Council District contribution for public safety improvements in your districts or for the broken assets in the Regional Park. I also urge you to have public meetings in each of your districts to assess how your constituents want their hard earned money spent. Fixing broken streets and scary unpaved alleys would seem to be of more public concern than 1 very expensive soccer field in East Long Beach.

CD5 Councilmember Mungo, if you have this amount of money to spend, why not use it for the urgent need for aerators in the ponds in El Dorado Regional Park or to repair the unsafe, broken, heavily used, and car damaging parking lot by the old ranger station in Area 3 of the Regional Park?
