On February 26, 2020, the Civil Service Commission received correspondence from the Long Beach Police Department requesting to return released probationary employees to the current Police Recruit eligible list in accordance with Article VII, Section 89 and 90 of the Civil Service Rules and Regulations.

## The following information is presented for consideration:

- The Police Department is requesting the return of two Police Recruit candidates, Mr. Inmer Rosa, in accordance with Section 89 and Mr. Freddy Lopez, in accordance with Section 90, to the current Police Recruit eligible list, Test #3.
- Mr. Lopez was hired by the Police Department from the Police Recruit eligible list on August 20, 2019 and participated in the Police Academy Class of 94 but was released during the probationary period on September 18, 2019.
- Mr. Rosa was hired as a Special Services Officer III on July 13, 2015 and attained permanent status on January 12, 2016. On August 24, 2019, he was hired from the Police Recruit eligible list and participated in the Police Academy Class of 94 but was released during the probationary period on September 14, 2019. In accordance with Section 89 of the Civil Service Rules and Regulations, Mr. Rosa was reinstated to the Special Services Officer classification which he held status prior to his Police Recruit appointment.
- The Police Department stated Mr. Lopez and Mr. Rosa were unable to complete the Academy training, but the Department wishes to rehire Mr. Lopez and Mr. Rosa for the upcoming Police Academy Class of 95 scheduled to start on July 28, 2020.
- Staff has verified that the Police Recruit eligible list, Test #3 is still current and will expire on May 28, 2020.
- Staff has notified the Police Department and the Police Recruit candidates that this request is placed on the March 4<sup>th</sup> Civil Service Commission agenda.
