WHEREAS, the City of Long Beach (the "City") launched their Bike Share Program (the "Program") in March 2016; and

NOT TO EXCEED \$225,000

WHEREAS, MobilityCloud, Inc. acquired 500 new bicycles as part of their transition from Social Bicycles; and

WHEREAS, Mobility Cloud, Inc. has offered to sell these 500 bicycles to the City for 30% of the market rate; and

WHEREAS, these bicycles are new versions of the existing Program bicycles and are compatible with the current system; and

WHEREAS, it is more cost-effective and efficient to purchase the significantly discounted bicycles from MobilityCloud, Inc. because they are the only bicycles compatible with the existing system; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary
