TWELFTH AMENDMENT TO AGREEMENT NO. 33387

THIS TWELFTH AMENDMENT TO AGREEMENT NO. 33387 is made and entered, in duplicate, as of March 11, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 10, 2020, by and between APOLLO PROFESSIONAL SOLUTIONS, a Massachusetts corporation, with offices located at 4010 Watson Plaza Dr., Suite 138, Lakewood, California 90712 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33387 (the "Agreement") whereby Consultant agreed to provide professional and technical services for information technology projects and systems on an as-needed basis; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to clarify the terms of the Agreement; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to January 22, 2017 and increase the total not to exceed amount to \$500,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the total not to exceed amount to \$600,000; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to increase the total not to exceed amount to \$800,000; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to increase the total not to exceed amount to \$1,000,000; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to increase the total not to exceed amount to \$1,500,000 and extend the term to January 22, 2018; and

WHEREAS, the Parties entered into a Seventh Amendment to the Agreement to increase the total not to exceed amount to \$2,000,000; and

WHEREAS, the Parties entered into an Eighth Amendment to the Agreement

to increase the total not to exceed amount to \$3,000,000 and extend the term to January 22, 2019; and

WHEREAS, the Parties entered into a Ninth Amendment to the Agreement to increase the total not to exceed amount to \$3,300,000 and extend the term to May 22, 2019: and

WHEREAS, the Parties entered into a Tenth Amendment to the Agreement to increase the total not to exceed amount to \$4,000,000 and extend the term to October 22, 2019; and

WHEREAS, the Parties entered into an Eleventh Amendment to the Agreement to extend the term to March 22, 2020; and

WHEREAS, the Parties desire to decrease the Agreement by \$500,000 for a total not to exceed amount of \$3,500,000 and extend the term to July 22, 2020;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 1.A. of the Agreement is hereby amended to read as follows: 1.
- "Α. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, a total not to exceed contract amount of Three Million Five Hundred Thousand Dollars (\$3,500,000), at the rates or charges shown in Exhibit "A"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:
- **°**2. TERM. The term of this Agreement shall commence on February 24, 2014, and shall terminate on July 22, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33387 are ratified and confirmed and shall remain in full force and effect.
