## FOURTH AMENDMENT TO AGREEMENT NO. 34195

## 34195

THIS FOURTH AMENDMENT TO AGREEMENT NO. 34195 is made and entered, in duplicate, as of March 6, 2020 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 7, 2020, by and between ARMIJO ENTERPRISES, INC. DBA BRADFIELD DESIGN, a California corporation ("Consultant"), with a place of business at 3101 East 2nd Street, Unit 6-A, Long Beach, California 90803, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34195 (the "Agreement") whereby Consultant agreed to provide as-needed graphic design and creative services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to November 30, 2018 and add \$5,000 for a total not to exceed amount of \$38,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$17,000 for a total not to exceed amount of \$55,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to November 30, 2019 and add \$25,000 for a total not to exceed amount of \$80,000; and

WHEREAS, the Parties desire to extend the term to July 31, 2020;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 2 of the Agreement is hereby amended to read as follows: 1.
- "2. TERM. The term of this Agreement shall commence at midnight on December 1, 2015, and shall terminate at 11:59 p.m. on July 31, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
