WHEREAS, Phase II is a multi-year Program; projects will be constructed in a series of phases and are anticipated to be completed in 2022; and

WHEREAS, Contract No. 34389 is set to expire in August 2020; and WHEREAS, Anser submitted a proposal for continued construction management services for an estimated contract execution date through the end of the Phase II Program; and

WHEREAS, Anser has demonstrated extreme dedication and quality performance on the Phase II Program; many key personnel, including the Senior
