# Request for Permanent Assignment to Former Classification Form (Revert)

#### **PURPOSE:**

To request permanent assignment to former classification for an employee.

#### **RELEVANT RULES AND REGULATIONS/POLICY:**

Civil Service Rules and Regulations Section 67 (1):

"Permanent assignment to a position in a classification from a position in another classification shall be contingent on the approval of the appointing authority, the heads of the departments involved, and the approval of the Commission and shall be accomplished in accordance with this section. An employee may be permanently assigned to:

(1) A former classification in which he/she held permanent status if requested by the employee, or involuntarily to a former or lower classification for disciplinary reasons pursuant to Article VII of these rules. An employee involuntarily demoted to a lower classification shall not serve a probationary period."

#### **PROCESS:**

- Requesting department should contact Civil Service Deputy Director to determine if the request is needed.
- Requesting department completes Request for Permanent Assignment to Former Classification Form.
  - The requesting department completes Section I of this form. Civil Service completes Section II of this form.
- Request Form emailed to Civil Service Department Executive Assistant
- Request will be placed on the agenda for the upcoming Commission meeting.
- At Commission meeting, department is present to address questions from the Commission.
- Commission Approves/Denies request.

**CLASSIFICATION – JASON FERGUSON** 

On May 12, 2020, the Civil Service Commission received correspondence from the Public Works Department, requesting the transfer and permanent assignment to his former classification for Jason Ferguson, Senior Survey Technician, in accordance to Article VI, Section 67(1) of the Civil Service Rules and Regulations.

#### **Facts for Consideration:**

- Mr. Jason Ferguson was hired as a Construction Inspector I with the Department of Public Works on October 22, 2018. He passed probation and obtained permanent status on May 3, 2019.
- On February 15, 2020, Mr. Ferguson was selected from the Senior Survey Technician eligible list with the Department of Public Works, where he is currently on probation.
- On May 7, 2020, the Department of Public Works received correspondence from Mr. Ferguson requesting to revert to his former classification of Construction Inspector.
- The Department of Public Works has had several vacancies in the Construction Inspector classification. The current eligible list was established on June 11, 2019.
- The Department of Public Works has a current Construction Inspector vacancy and staff has verified that the Civil Service Department received the requisition, PW20-032 on December 3, 2019.
- If Commission approves this request, Mr. Ferguson will forfeit all the time earned during his probationary period as a Senior Survey Technician since he did not complete his probationary period.
- If reappointed to Senior Survey Technician, a new probationary period will be required.
- Mr. Ferguson will not serve a new probationary period in the classification of Construction Inspector since earning permanent status previously on May 3, 2019.
- Staff has informed Mr. Ferguson of the terms and conditions of this

permanent assignment to his former classification and has been notified that this request will be placed on the Commission agenda.

 A representative from the Department of Public Works will be available to answer any questions the Commission may have regarding this request.

#### **Recommendation:**

 Staff has reviewed the request and recommends that the Commission approve the request for permanent assignment to former classification for Mr. Ferguson in accordance with Article VI, Section 67(1) of the Civil Service Rules and Regulations.
