### RECOMMENDATION:

Confirmation of the City Manager's promulgation of the revised Safer at Home Health Order, issued on May 13, 2020 by the City of Long Beach Health Officer as a regulation. (Citywide)

### DISCUSSION

On March 19, 2020, to mitigate the effects of COVID-19 within Long Beach, the City's Health Officer issued the "Safer at Home Order for Control of COVID-19" (Health Order) and has revised the Health Order from time to time as necessary for the public health and safety during this ongoing emergency. On May 13, 2020, the City's Health Officer issued a revision to the Health Order to begin transitioning the City into Stage 2 of the Governor's Roadmap to Recovery (Attachment).

On May 12, 2020, the City Council adopted Long Beach Municipal Code (LBMC) Chapter 8.120, "Temporary Enforcement of Long Beach Health Orders Related to COVID-19," which became effective immediately as an urgency Ordinance. Chapter 8.120 requires, where practicable, the City Council to confirm COVID-19 Health Orders for the sole purpose of authorizing the City Manager's promulgation of such Health Orders. In the event it is not feasible to do this, the City Manager is required to, within 14 days of promulgation of said Health Orders, request the City Council to confirm the City Manager's promulgation of the Health Order. The City Manager's promulgation of the Health Order, and City Council's confirmation of such orders authorizes enforcement authority of the Health Orders under the Proclamation of Local Emergency and provisions of Chapter 8.120.

This process recognizes a potential need for the City's Health Officer to quickly amend or update, and the City Manager to promulgate as a regulation under the LBMC for protection of life and property as affected by the COVID-19 emergency, City Health Orders due to the rapid development of COVID-19, while still ensuring the City Council maintains oversight of the COVID-19 local emergency and the City Manager's promulgation of related orders.

This matter was reviewed by Deputy City Attorney Taylor M. Anderson and Budget Manager Grace Yoon on May 15, 2020.

TIMING CONSIDERATIONS

City Council action is requested on May 19, 2020.

STATEMENT OF URGENCY

Confirmation by the City Council of the revised Health Order within 14 days of promulgation is a requirement of LBMC Section 8.120. The Health Order was revised and promulgated on May 13, 2020.

FISCAL IMPACT

The full fiscal impact of the implementation and enforcement of the revised Health Order is unknown at this time due to the unprecedented and quickly changing nature of the response to the pandemic. The Health Order and its amendments have an inherent impact on the health of the community and economic activity of Long Beach. There is substantial evidence provided through various public City reporting that the Health Order and its amendments are positively impacting the health and safety of Long Beach residents; and, there is substantial evidence, also provided through other public documents issued by the City, that the Health Order and its amendments are negatively impacting the economy and the City's financial status. As the Health Order is modified from time to time, the modifications are intended to ensure compliance with State directives and to strike a balance, appropriate at the time of modification, between the safety and well-being of residents and other important considerations such as economic impacts. This recommendation has no staffing impact beyond the normal budgeted scope of duties and is consistent with existing City Council priorities. .

## **SAFER AT HOME ORDER FOR CONTROL OF COVID-19**

Continuation of the Safer at Home Order to  
Begin Transitioning the City into  
Stage 2 of the Governor's Roadmap to Recovery  
REVISED ORDER ISSUED: May 13, 2020

**Please read this Order carefully. Violation of or failure to comply with this Order is a crime punishable by fine, imprisonment, or both. (Ca. Health & Safety Code § 120275 et seq; Long Beach Municipal Code § 8.120.030.A and 8.120.030.E.3)**

**Summary:** This Long Beach Health Officer Order (Order) amends and supersedes all prior orders issued on March 12, March 16, March 19, March 20, March 24, March 28, April 1, April 15, and May 8, 2020 (Prior Orders) to control the spread of the Novel Coronavirus (COVID-19) within the City of Long Beach (City). This Order is issued to comply with Executive Order N-33-20 issued by Governor Gavin Newsom, wherein the State Public Health Officer ordered all individuals living in the State of California to stay home or at their place of residence, except as needed to maintain continuity of operations of the federal critical infrastructure sectors. Existing community transmission of COVID-19 in the City continues to present a substantial risk of harm to health of the City's residents. Evidence suggests that the restrictions and requirements imposed by the Health Officer's Prior Orders have slowed the rate of increase of COVID-19 community transmission and related hospitalizations by severely limiting person-to-person interactions. This Order is a measured step to partially move the City into Stage 2 of the Governor's Roadmap to Recovery, while keeping a low incidence of person-to-person contact, ensuring continued Physical Distancing by the community, and strict adherence to other infection control protocols.

This Order also allows limited solo or family outdoor active recreational activities on public beaches. The use of chairs, canopies, coolers, grills, sunbathing, or any similar stationary activity on the beach is prohibited. Additionally, this Order allows for dog parks and dog beaches to open to the public, provided that individuals strictly engage in Physical Distancing Measures. Outdoor museums may open outdoor spaces to the public provided Physical Distancing Protocol is implemented prior to operation. Stationary activities or exhibits that involve touching or contact of any kind at outdoor museums are prohibited.

This Order continues to allow the operation of Lower-Risk Businesses for curbside pickup or deliver provided the business implements and posts a site-specific Physical Distancing Protocol prior to operation. Essential Businesses must continue to implement a Physical Distancing Protocol to protect workers, the community, and the public from COVID-19.

This Order allows persons to engage in essential activities, as defined by the Order, but requires persons to at all times, practice Physical Distancing while out in public, to lower the risks of person-to-person contact for themselves and others. As recreational sites and businesses open it's critical that the community and the public remains vigilant with physical distancing and hygiene practices that prevent the spread of COVID-19, like frequent hand washing, physical distancing, and staying home when sick.

The Health Officer will continue to monitor the rate of COVID-19 disease spread, the severity of the resulting illnesses and deaths caused, CDPH and Centers for Disease Control and Prevention (CDC) recommendations, and the effect of this Order. If needed, this Order may be extended, expanded, or otherwise modified to protect the public's health.

**UNDER THE AUTHORITY OF CALIFORNIA HEALTH AND SAFETY CODE  
SECTIONS 101040, 101085, AND 120175, THE HEALTH OFFICER OF THE CITY  
OF LONG BEACH ORDERS AS FOLLOWS:**

1. Effective immediately on May 13, 2020 and continuing until further notice:
  - a. All persons are to remain at their place of residence, except as follows and provided that Physical Distancing Measures are strictly adhered to:
    - i. To work at or visit an Essential Businesses or Lower-Risk Businesses;
    - ii. To work at, to provide service to, or obtain treatment from a Healthcare Operation
    - iii. To work at or provide service to Essential Infrastructure;
    - iv. To engage in Essential Activities, and
    - v. To perform Minimum Basic Operations for businesses whose on-site operations must remain temporarily closed pursuant to this Order.
    - vi. Persons experiencing homelessness are exempt from this Section but are strongly urged to obtain shelter and abide by Physical Distancing Measures.
  - b. All public and private gatherings of any number of people occurring outside a single household are prohibited within the City, except for the limited purposes expressly permitted by this Order. Nothing in this Order prohibits members of a single household from engaging in Essential Activities together.
  - c. The following businesses may operate for limited operations, as indicated herein:
    - i. Lower-Risk Businesses for curbside pickup or delivery only and subject to the restrictions herein. Customers shall not be permitted to enter the business facility and shall engage in Physical Distancing Measures required by this Order. Lower-Risk Businesses shall implement a Retail Physical Distancing Protocol found [here](#) prior to operation.
    - ii. Automobile dealerships showrooms or operations. Automobile dealerships shall implement a Physical Distancing Protocol is implemented pursuant to Section 3 of this Order and in adherence to [industry-specific State guidance](#) at <https://covid19.ca.gov/roadmap/> prior to operation.

- iii. Self-service car washes. Self-service car washes shall implement a Physical Distance Protocol pursuant to Section 3 of this Order prior to operation. Self-service washes include car washes where a person can wash their own car in a stall alone and exterior automated car washes, both free-standing and those connected with a gas station. Vacuums are allowed if Physical Distancing Measures are adhered to and the hoses are sanitized after each use. Full-service car washes are prohibited, including, but not limited to, a car wash where an attendant vacuums the car, drives the car through the car wash, or manually dries and polishes the car and/or cleans the interior.
- d. The following recreational businesses and sites may open for limited uses, subject to the restrictions herein:
- i. Park parking lots, beach bike and pedestrian paths that traverse the sanded portion of the beach, public trails, trailheads, dog parks, and dog beaches. may open to the public provided that Physical Distancing Measures are strictly adhered to including donning a Face Covering while in Close Contact with other people. Face Coverings are not required while engaging in physically distanced exercise.
  - ii. Tennis centers may operate provided a Tennis Physical Distancing Protocol found [here](#) is implemented prior to operation. Concession stands and restaurants located on-site may operate for take-out only. Non-Essential Retail on-site at a tennis center, must operate for curbside pickup or delivery only. This subsection does not allow for large events, such as tournaments or the operation tennis courts located within gyms or fitness centers.
  - iii. Public and Private golf courses, including any associated parking lots, provided the golf course implements a Golf Course Physical Distancing Protocol found [here](#) prior to operation. This subsection does not allow for gatherings, including, but not limited to, fundraisers and tournaments.
  - iv. Outdoor museums may open outdoor spaces to the public for the limited purpose of outdoor recreational activities, such as walking, provided that a Physical Distancing Protocol pursuant to Section 3 of this Order is implemented prior to operation. All indoor portions of the museum shall remain closed to the public. Stationary activities or exhibits that involve touching or contact of any kind are prohibited. This subsection does not allow for gatherings.
  - v. Public beaches may open for the limited purpose of active recreational activities by individuals or members of the same householding, such as, swimming in the ocean, running, walking, kitesurfing, kayaking, or other similar activities. Gatherings of any size are prohibited, including,

but not limited to, events, athletic competitions, youth camps, and recreational programming. The use of chairs, canopies, coolers, grills, sunbathing, or any similar stationary activity on the public beach are prohibited.

2. The Health Officer orders the continued closure of the following types of activities, properties, recreational sites, and higher-risk businesses, where more intense and prolonged person-to-person contacts are likely to occur:
  - a. Indoor Malls and Indoor Shopping Centers, including all stores and vendors located therein regardless whether they are Essential or Lower-Risk Business. As an exception, Essential and Lower-Risk Businesses that are part of an Indoor Mall or Indoor Shopping Center, but that are normally accessible by the public from the exterior of the Indoor Mall or Shopping Center may operate for curbside pickup or delivery only. The interior of the Indoor Mall or Indoor Shopping Center shall remain closed to the public. For purposes of this Order, Indoor Mall or Shopping Center is defined as: A building with seven (7) or more sales or retail establishments with adjoining indoor space.
  - b. Indoor or outdoor playgrounds for children, except for those located within childcare centers.
  - c. Indoor and outdoor flea markets and swap meets.
  - d. All basketball courts, volleyball courts, playgrounds, skate parks, and picnic areas.
  - e. All piers, public beach parking lots, and beach access points.
  - f. Bars and nightclubs that do not serve food.
  - g. Gyms and fitness centers, including, but not limited to, private gyms and fitness centers located in multifamily housing complexes, such as, apartment buildings and condominiums.
  - h. Movie theaters, drive-in theaters, live performance theaters, concert halls, arenas and stadiums.
  - i. Bowling alleys and arcades.
  - j. The portion of wineries, breweries, and tap rooms that provide tastings to the public. This subparagraph (l) does not restrict the ability of such businesses to offer pickup or delivery.
  - k. Sidewalk or street vending of retail goods and/or services. This subparagraph (k) does not restrict the ability of mobile food or flower vendors to operate so long as the business operates pursuant to this Order, including implementation of a Physical Distancing Protocol. "Vending" includes any good or service provided for no cost.

- i. All swimming pools, spas, hot tubs, splash pads, saunas, and steam rooms, except as follows:
  - i. Those located in a single-family residence, which shall be used only by members of the household residing at the single-family residence.
  - ii. Medical or therapy pools that provide medically prescribed and/or medically necessary supervised therapy. Therapy sessions should employ Physical Distancing Protocols of at least six (6) feet at all times possible.
  - iii. Routine maintenance, including, cleaning, chemical balancing and adjustments are permitted at any facility required to closed by this subsection.

m. Indoor museums, indoor or outdoor children museums, and gallery spaces. This subparagraph(o) does not restrict the ability of such establishments from selling retail products for curbside pickup or delivery.
3. All Essential Businesses and Lower-Risk Businesses shall prepare and post a [Physical Distancing Protocol](#) (attached as Appendix A), or any industry-specific protocol required by this Order, at each of their facilities in the City frequented by the public or employees. Any requirements not specified in the Physical Distancing Protocol but required under the State's industry-specific guidance at <https://covid19.ca.gov/roadmap/> shall be addressed in the business's Physical Distancing Protocol. The Physical Distancing Protocol must be posted at or near the entrance of the relevant facility, and shall be easily viewable by the public and employees. A copy of the Physical Distancing Protocol must also be provided to each employee performing work at the facility. All Essential Businesses and Lower-Risk Businesses shall implement the Physical Distancing Protocol and provide evidence of its implementation to any authority enforcing this Order upon demand. To the extent feasible, Essential Infrastructure shall comply with this Section. The Physical Distancing Protocol must explain how the business is achieving the following, as applicable:
  - a. Limiting the number of people who can enter into the facility at any one time to ensure that people in the facility can easily maintain a minimum six-foot distance from one another at all times, except as required to complete an business activity. As a general rule, the number of people allowed in the facility at one time should be fifty percent (50%) of allowed occupancy, or otherwise adjusted to easily maintain a minimum six-foot distance depending on the size of the facility. Persons who are family members or household contacts, may stand or move together, but must be separated from others by a distance of at least six (6) feet.
  - b. Where lines may form at a facility, marking six-foot increments at a minimum, establishing where individuals should stand to maintain adequate physical distancing, whether outside or inside the facility.
  - c. Providing, at the business' expense, hand sanitizer that contains at least 60%

alcohol, soap and water, or disinfectant qualified for use against COVID-19 at or near the entrance of the facility and in other appropriate areas for use by the public and employees, and in locations where there is high-frequency employee interaction with members of the public (e.g. cashiers).

- d. Providing for the regular disinfection of high-touch surfaces, and disinfection of all payment portals, pens, and styluses after each use. Businesses are encouraged to also offer touch-less payment mechanisms, if feasible.
- e. Providing physical space between employees and customers (e.g. plexiglass at point of sale locations, drive through, partitions).
- f. Regularly disinfecting other high-touch surfaces.
- g. Posting a sign at the entrance of the facility informing all employees and customers that they should: (i) avoid entering the facility if they are experiencing symptoms of respiratory illness, including cough or fever; (ii) to maintain a minimum six-foot distance from one another; (iii) sneeze and cough into one's elbow; (iv) not shake hands or engage in any unnecessary physical contact.
- h. Require, and permit adequate time for, employees to wash their hands at least every 30 minutes, or as needed if gloves are provided. Where hand washing is impracticable to the nature of the employee's work, the employer shall provide hand sanitizer that contains at least 60% alcohol to the employee. Such employees shall also be required and permitted adequate time to sanitize their hands at least every 30 minutes, or as needed if gloves are provided.
- i. Ensure sanitary bathrooms are made available to employees, which are stocked with necessary soap, towels, toilet seat covers, and toilet paper.
- j. Providing, at the employer's expense, Face Coverings for employees and contracted workers whose duties require Close Contact with other employees and/or the public, as well as appropriate training on their proper use. "Close Contact" means being within 6 feet of another person for 10 minutes or more.
- k. Require that employees and contracted workers whose duties require Close Contact with other employees and/or the public wear Face Coverings. "Close Contact" means being within 6 feet of another person for 10 minutes or more.
- l. Require that members of the public who enter the facility wear a Face Covering during their time in the facility. An Essential Business may refuse admission or service to any individual who fails to wear a Face Covering required by this subsection.
- m. For Lower-Risk Businesses:
  - i. Prohibit customers from entering the facility.
  - ii. Require use of Face Coverings and gloves and/or frequent handwashing pursuant to Section 3(h) for interaction with customers



during pickups and deliveries.

- iii. Customers are required to wear face coverings during pickups.
  - iv. Refrain from impeding the right-of-way and/or ADA accessibility on sidewalks, surrounding areas, and other businesses during pickups. This includes, but is not limited to, creating a system for people to stand in socially distanced line, indicators on the ground where people should stand, and any other crowd control measures.
  - v. Posting a sign at the entrance of the facility that customers are prohibited from entering the facility.
  - vi. Receiving payment by phone or online prior to pickup is strongly encouraged.
  - vii. Provide adequate security or staffing to implement any necessary crowd control.
  - viii. Implement and post a [Retail Physical Distancing Protocol](#) pursuant to this Section prior to operating.
- n. For Retail Food, drug retail, food delivery service, and hospitality employers:
- i. Ensure sufficient staffing to properly clean the facilities and shopping carts between use.
  - ii. Provide adequate security or staffing to implement any necessary crowd control and Physical Distancing Protocols.
  - iii. Develop protocols to establish operating hours to better serve vulnerable populations and ensure adequate time to re-stock stores.
  - iv. Require use of Face Coverings and gloves and/or frequent handwashing pursuant to Section 3(h) for interaction with customers, food preparation, and food delivery.
- o. Make every effort to implement and adhere to Physical Distancing Protocols with employees, including, but not limited to:
- i. Allow employees to telecommute (i.e. work from home);
  - ii. Allow for flexible schedules, such as, staggering schedules of employees so less individuals occupy a worksite at any given time;
  - iii. Separate employees by at least six (6) feet;
  - iv. Allow teleconferencing or video conferencing for meetings; and
  - v. Limit meetings or gatherings of any sort, especially in locations where

employees could interact or come in contact with any member of the public. This includes limiting or eliminating (1) employees from traveling in vehicles together and/or (2) the need for employees to physically work in teams of two or more. If meetings or gatherings are absolutely necessary, Essential Businesses must implement Physical Distancing Protocols to the extent practicable.

- p. Any additional physical distancing measures being implemented (see the Centers for Disease Control and Prevention's guidance at: <https://www.cdc.gov/coronavirus/2019-ncov/community/guidance-business-response.html>).
4. Essential Businesses and Lower-Risk Businesses are directed to continue to maximize the number of employees who work from home. Essential Businesses must follow guidance for businesses and any industry-specific guidance issued by the CPDH, CDC, the Health Officer related to COVID-19.
5. Licensed Cannabis Dispensaries approved by the City to deliver cannabis may provide curbside pickup service under the following conditions:
  - a. Customers must submit proof of a valid government-issued identification prior to the curbside pickup.
  - b. Upon pickup, the Dispensary must verify that the identification of the customers is the same person who ordered curbside pickup via a valid government-issued identification.
  - c. Products must be delivered to customers in opaque packaging.
  - d. Uniformed and licensed security personnel must be present during all curbside pickup transactions.
  - e. All other local and State laws, regulations, and lawful orders are adhered to.
  - f. The City Manager is authorized to issue reasonable rules and policies to further restrict curbside pickup activities allowed by this Section to protect the health, safety, and welfare of the residents of Long Beach and the public.
6. Any and all City regulations governing the sale of alcoholic beverages are modified to allow:
  - a. Restaurants and bars that prepare and serve food for off-site consumption to sell alcoholic beverages together with food for delivery and take-out.
  - b. Sales, by retail stores, of alcoholic beverages for off-site consumption, including deliveries and extended sales hours, from 6 a.m. to 2 a.m. daily.
7. This Order considers employees of government agencies working in the course and scope of their public service employment to be Essential Infrastructure.

- a. This Order declares that all government employees to be essential, including, but not limited to, health care providers and emergency responders.
- b. While all government employees are essential, employees called to serve in their Disaster Service Worker capacity must be available to serve the public or assist in response or continuity of operations efforts during this public health crisis to the maximum extent allowed under the law.

### REASONS FOR THE ORDER

8. This Order supersedes the Health Officer's Prior Orders. In light of the progress achieved in slowing the spread of COVID-19 in the City, this Order allows the conditional reopening of specific businesses and recreational sites, including retail and limited services. This limited and measured step is intended to begin the City's transition into Stage 2 of the Governor's Roadmap to Recovery, while keeping a low incidence of person-to-person contact by ensuring continued Physical Distancing and adherence to other infection control protocols, as provided below. The Health Officer will assess the activities allowed by this Order on an ongoing basis and determine whether this Order needs to be modified if the public health risk associated with COVID-19 increases in the future.
9. Although this Order allows some activities and business operations to resume, physical distancing and good hygiene practices remain the most effective tool available to prevent the spread of virus between people. This Order's intent is to continue to ensure that City residents remain in their residences as much as possible and to limit Close Contact with others outside their household in both indoor and outdoor spaces. This includes all persons who can telework or work from home continuing to do so as much as feasible during the course of this pandemic. Sustained Physical Distancing Measures and infection control measures by residents will continue slow the spread of COVID-19, thereby diminishing its impact on the delivery of critical healthcare services. All provisions of this Order must be interpreted to effectuate this intent. Failure to comply with any of the Order's provisions constitutes an imminent threat and menace to public health, and a public nuisance, and is punishable by fine, imprisonment or both.
10. This Order is based upon scientific evidence and best practices, as currently known and available, to protect members of the public from avoidable risk of serious illness and death resulting from the spread of COVID-19, as well as to protect the healthcare system from a surge of cases into its emergency rooms and hospitals. The intent of this Order is to ensure that the maximum number of people remain in their places of residence to the maximum extent feasible to stem the spread of COVID-19 and mitigate the impact on delivery of critical healthcare services to those in need, as well as to protect the healthcare system from a surge of cases into emergency rooms and hospitals. The Order supports the CDC's efforts to institute more stringent and necessary Physical Distancing Measures to reduce community transmission of COVID-19.
11. Evidence suggests that the restrictions and requirements imposed by Prior Orders

slowed the rate of increase in community transmission and hospitalizations by limiting interactions among people, consistent with the efficacy of similar measures in other parts of the country and world. Although the hospitals within the City are seeing increased numbers of COVID-19 patients, including patients with severe illness, the hospitals have not become overwhelmed or exceeded capacity. However, because there is not yet a vaccine or proven therapeutic drug, the public health emergency and attendant risks to the public's health by COVID-19 still predominate.

12. This Order is issued in light of existing community transmission of COVID-19 in the City which presents a substantial and significant risk of harm to the health of residents. Currently, there is no vaccine available to protect against and no specific treatment for COVID-19. As of May 13, 2020, there have been at least 984 cases of COVID-19 and 48 deaths reported in the City of Long Beach, and 33,180 cases of COVID-19 and 1,613 deaths reported in Los Angeles County. There remains a strong likelihood of a significant and increasing number of suspected cases of community transmission. Making the community transmission problem worse, some individuals who contract the virus causing COVID-19 have no symptoms or have only mild symptoms, and so are unaware that they carry the virus and are transmitting it to others. Further, evidence shows that the virus can survive for hours or even days on surfaces and can be indirectly transmitted between individuals. Since even people without symptoms can transmit the virus, and because evidence shows the infections is easily spread, preventing, limiting and placing conditions on various types of gatherings and other direct and indirect interpersonal interactions have been proven to reduce the risk of transmitting the virus.
13. In line with the State Public Health Officer, the City of Long Beach Health Officer is monitoring several key indicators ("COVID-19 Indicators") within the City. Progress on some of these COVID-19 Indicators – specifically related to hospital utilization and capacity – makes it appropriate, at this time, to ease certain restrictions imposed by the Prior Orders. However, the prevalence of the virus that causes COVID-19 requires other restrictions to continue. Activities and business operations that are permitted must be conducted in accordance with the required Physical Distancing Measure and Physical Distancing Protocols and any other infection control protocols ordered by the Health Officer.
14. The virus that causes COVID-19 can be spread easily through person-to-person contact. This risk of transmission is increased when people are in close proximity. All gatherings and pose an increased risk for community transmission of COVID-19 and thus, are a substantial risk to public health.
15. In the absence of a specific immunization or treatment for COVID-19, physical distancing is essential to preventing this disease. Increasing physical distancing, increasing worker protections, and prohibiting events and gatherings is intended to slow transmission of COVID-19. Accordingly, to reduce the community transmission of COVID-19, the Health Officer has ordered the temporary prohibition of all events and gatherings, the continued closure of certain commercial properties and businesses, and certain recreational sites that present a higher-risk of transmission of COVID-19 due to intense and prolonged person-to-person contact, and for Essential and Lower-Risk Businesses to prepare, post, and implement a Physical Distancing Protocol at each

facility at which they maintain operations.

16. The Health Officer will continue monitoring COVID-19 Indicators to determine when City is ready to move to through Stage Two and Stage Three of the Governor's Roadmap to Recovery. Those Indicators include, but are not limited to:
  - a. The trend of the number of new COVID-19 cases, hospitalization rates, and death rates.
  - b. The capacity of hospitals and the healthcare system in the City, including acute care beds, Intensive Care Unit beds, and ventilators to provide care for existing COVID-19 patients and other patients, and capacity to surge with an increase of COVID-19 cases.
  - c. The supply of personal protective equipment (PPE) available for hospital staff, nursing home staff and other healthcare providers and personnel who need PPE to safely respond to and treat COVID-19 patients and other patients.
  - d. The ability and capacity to quickly and accurately test persons to determine whether individuals are COVID-19 positive, especially those in vulnerable populations or high-risk settings or occupations, and to identify and assess outbreaks.
  - e. The ability to conduct case investigation and contact tracing for the volume of future cases and associated contacts, isolating confirmed cases and quarantining persons who have had contact with confirmed cases.

### DEFINITIONS

For Purposes of this Order, the following definitions shall apply:

17. For purposes of this Order, "Essential Activities" shall include travel for the purpose of engaging any Essential Activity. Individuals may leave their residences only to perform the following "Essential Activities":
  - a. To engage in activities or perform tasks essential to their health and safety, or to the health and safety of their family or household members (including, but not limited to, pets), such as, obtaining medical supplies or medication; visiting a health care or veterinary care professional; providing care for minors, the elderly, dependents, persons with disabilities, or other vulnerable persons; or providing care for pets.
  - b. To obtain necessary services or supplies for themselves and their family or household members, or to deliver those services or supplies to others, such as, to obtain supplies they need to work from home; to obtaining grocery items for one's household or for delivery to others; or to obtain any products necessary to maintain the safety, sanitation, and essential operation of residences.

- c. To engage in outdoor activity for the purpose of physical exercise (including outdoor activities with pets), such as, walking, cycling, hiking, running, tennis, or golf, provided individuals strictly comply with Physical Distancing Measures as defined in this Order.
  - d. To engage in legally mandated governmental purposes, such as, access to court, social, and administrative services or complying with an order of law enforcement or court.
  - e. To engage in any activity identified in Section 1(a).
18. “Lower-Risk Businesses” are defined as (1) retail establishments that provide goods or services to the public for curbside pickup or delivery only where there is a lower risk of transmission of COVID-19 due to little to no incidents of intense and/or prolonged person-to-person contact and (2) any non-retail business that is a manufacturing and logistics sector businesses which supplies such lower-risk retail establishments. “Lower-Risk Business” shall include services for animals/pets, such as, grooming, walking, and training.
19. “Essential Businesses” shall refer to those establishments whose primary business, per their City-issued business license is any of the following:
- a. Grocery stores, certified farmers’ markets, farm and produce stands, supermarkets, food banks, convenience stores, warehouse stores, and other establishments engaged in the retail sale of canned food, dry goods, fresh fruit and vegetables, animal/pet supply, water, fresh meats, fish, and poultry, and any other business where the primary function of the business is to sell household consumer products (such as cleaning products). This includes stores that sell groceries and sell other non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operation of residences;
  - b. Food processors, confectioners, food packagers, food testing labs that are not open to the public, and food cultivation, including farming, livestock, and fishing;
  - c. Organizations and businesses that provide food, shelter, and social services, and other necessities of life for economically disadvantaged or otherwise needy individuals (including gang prevention and intervention, domestic violence, and homeless service agencies);
  - d. Newspapers, television, radio, magazine, podcast and other journalism activities;
  - e. Gas stations, auto-supply, mobile auto-repair operations, automobile sales, auto repair shops, bicycle repair shops, towing and recovery services, and related distribution, sales, rental, leasing, repair, and maintenance facilities;
  - f. Banks, credit unions, financial institutions, and insurance companies;
  - g. Hardware stores, garden nurseries, building supply stores;
  - h. Plumbers, electricians, professional pest control, custodial/janitorial workers,

handyman services, funeral home workers and morticians, moving services, HVAC installers, carpenters, vegetation service, tree maintenance, landscapers, gardeners, property managers, private security personnel and other service providers who provide services to maintain the security, safety, sanitation, and essential operation to properties and other Essential Businesses;

- i. Businesses providing mailing and shipping services, including post office boxes;
- j. Educational institutions (including public and private K-12 schools, colleges, and universities) for purposes of facilitating distance learning, providing meals for pick-up, or performing Minimum Basic Operations, provided that Physical Distancing Measures are practiced;
- k. Laundromats, dry cleaners, and laundry service providers;
- l. Restaurants and other food facilities that prepare and serve food for delivery, drive-thru, or carry out. Indoor and outdoor table dining is not permitted. Cafeterias, commissaries, and restaurants located within hospitals, nursing homes, or other licensed health care facilities may provide dine-in service, as long as Physical Distancing Measures are practiced. Restaurants and bars that serve food may sell market products (such as, produce, pantry goods, meat, and eggs) if they offer such products for pickup or delivery only. Restaurants shall obtain market products for the customer. Restaurants are prohibited from converting indoor or outdoor seating areas into a market.
- m. Businesses that supply office or computer products needed by people who work from home;
- n. Non-manufacturing, transportation, or distribution businesses that ship, truck, transport, or provide logistical support to deliver groceries, food, goods or services directly to residences, Essential Businesses, Healthcare Operations, Essential Infrastructure, or Lower-Risk Businesses. This exemption shall not be used as a basis for engaging in sales to the general public from inside retail storefronts; curbside pickup or delivery is permitted;
- o. Airlines, taxis, ride sharing services, and other private transportation providers providing transportation services necessary for activities of daily living and other purposes expressly authorized in this Order;
- p. Businesses that provide manufacture and/or provide necessary service for Essential Infrastructure and Healthcare Operations;
- q. Businesses that supply other Essential Businesses with the support or supplies necessary to operate;
- r. Home-based care for seniors, adults, people with a disability, or children;
- s. Residential facilities and shelters for people experiencing homelessness, seniors,

adults, people with a disability, and children;

- t. Professional services, such as legal, payroll, or accounting services, when necessary to assist in compliance with legally mandated activities, and the permitting, inspection, construction, transfer and recording of ownership of housing, including residential and commercial real estate and anything incidental thereto, provided that appointments and other residential viewings must only occur virtually or, if a virtual viewing is not feasible, by appointment with no more than two visitors at a time residing within the same household or living unit and one individual showing the unit (except that in-person visits are not allowed when the occupant is still residing in the residence) and following Physical Distancing Protocols;
- u. Military/Defense Contractors/FFRDC (Federally Funded Research and Development Centers). For purposes of this Order, essential personnel may leave their residence to provide any service or perform any work deemed essential for national security including, but not limited to defense, intelligence and aerospace development and manufacturing for the Department of Defense, the Intelligence Community, and NASA and other federal government, and or United States Government departments and agencies. Essential personnel include prime, sub-primes, and supplier contractor employees, at both the prime contract level and any supplier levels at any tier, working on federal United States Government contracts such as contracts rated under the Defense Priorities and Allocations System (DPAS) and contracts for national intelligence and national security requirements;
- v. Childcare facilities providing services that enable employees exempted in this Order to work as permitted. To the extent possible, childcare facilities must operate under the following mandatory conditions:
  - i. Childcare must be carried out in stable groups of 12 or fewer ("stable" means the same twelve (12) or fewer children are in the same group each day);
  - ii. Children shall not change from one group to another;
  - iii. If more than one (1) group of children is cared for at one (1) facility, each group shall be in a separate room. Groups shall not mix with each other; and
  - iv. Childcare providers shall remain solely with one group of children.
- w. Hotels, motels, shared rental units, and similar facilities.
- x. Businesses that provide death care services, limited to the removal, care, and preparation, and burial of deceased persons or animals.
- y. Construction, which includes the operation, inspection, and maintenance of construction sites and construction projects for construction of commercial, office and institutional buildings, residential, mixed-use, and housing construction.



- z. Manufacturers and retailers of fabric or cloth that is made into personal protective equipment, such as, Face Coverings. These businesses may provide their products to purchasers by delivery or pick-up but may not be open to the public.
20. "Physical Distancing Measures" means (1) maintaining at least six-foot physical distance from other individuals, (2) frequently washing hands with soap and water for at least twenty seconds as frequently as possible or using hand sanitizer that contains at least 60% alcohol, (3) covering coughs or sneezes (into the sleeve, elbow, or tissue, not hands), (4) regularly cleaning high-touch surfaces, (5) not shaking hands; (6) avoiding all social interaction outside the household when sick with fever or cough, (7) wearing a Face Covering while when in Close Contact with others, excluding contact with members of a single household. "Close contact" means being within 6 feet of another person for 10 minutes or more.
  21. "Retail Food" means Essential Businesses identified in Section 19(a) and 19(l) of this order.
  22. "Face Covering" or "Face Coverings" means a cloth cover that fully covers the tip and nostrils of the nose and the mouth. Face Coverings required by this Order are not surgical masks or N-95 respirators. Per CDC guidelines, surgical masks and N-95 respirators are critical supplies that must continue to be reserved for healthcare workers and other medical first responders.

**Face Coverings should not be used as a substitute for other evidence-based measures to prevent the spread of COVID-19. Face Coverings should be used in addition to, but not in place of, other evidence-based measures (e.g. physical distancing; frequent hand washing practices; avoiding touching our eyes, nose and mouth with unwashed hands; avoiding being around sick people).**

23. "Close Contact" means being within 6 feet of another person for 10 minutes or more.
24. "Healthcare Operations" includes, but shall not be limited to: hospitals, clinics, laboratories, dentists, optometrists, pharmacies, physical therapists, and chiropractors; pharmaceutical and biotechnology companies; other licensed healthcare facilities, healthcare suppliers, home healthcare service providers, mental or behavioral health providers; alcohol and drug treatment providers; medical cannabis dispensaries with all required state and local licenses; medical or scientific research companies or any related and/or ancillary healthcare services; manufacturers, distributors and servicers of medical devices, diagnostics, and equipment (including personal protective equipment); veterinary care; and all healthcare provided to animals. This Order does not apply to businesses that provide support, supplies, or services deemed essential as part of the supply chain to Healthcare Operations. This exemption shall be broadly construed to avoid any impact to the delivery of healthcare, broadly defined. Healthcare Operations does not include fitness and exercise gyms and similar exercise or training facilities. In working for, volunteering at, or obtaining services from Healthcare Operations, individuals must comply with the specific Physical Distancing Measures and infection control guidance for that clinical or non-clinical setting.

25. "Essential Infrastructure" includes, but shall not be limited to: public health, public works construction; airport operations; port operations; water; sewer; gas; electrical; oil refining and extraction; road and highways; public transportation; solid waste collection and removal; emergency services; flood control and watershed protection; internet and telecommunications systems (including the provision of essential global, national, local infrastructure for computing services, business infrastructure, communications, and web-based services); and manufacturing and distribution companies deemed essential as part of the Essential Infrastructure supply chain, provided that they carry out those services or that work in compliance with Physical Distancing Measures, to the extent practical.

### ADDITIONAL TERMS

26. The persons and businesses subject to this Order that are required to cease in-person operations, but may continue to work from home, may travel to those businesses for purposes of Minimum Basic Operations, which means:
- a. The minimum necessary activities to maintain and protect the value of the business's inventory and facilities; ensure security, safety, and sanitation; process payroll and employee benefits;
  - b. The minimum necessary activities to facilitate owners, employees, and contractors of the business being able to continue to work remotely from their residences, and to ensure that the business can deliver its service remotely.
27. This Order does not, in any way, restrict: (a) first responder access to the site(s) named in this Order during an emergency or (b) local, state or federal officers, investigators, or medical or law enforcement personnel from carrying out their lawful duties at the site(s) named in this Order. Government agencies are expected to follow this order to the fullest extent possible, with limited exceptions as needed to continue to sustain critical government operations.
28. This Order does not, in any way, prohibit fishing from the shore, in accordance with Cal. Const., art. I, § 25, nor does it prohibit an individual from traversing the sand to enter the ocean to launch a boat, kayak, and the like.
29. This Order does not, in any way, prohibit individuals from utilize walking paths, both paved any unpaved, located within public parks for the purpose of engaging in outdoor Essential Activities provided that Physical Distancing Measures are strictly followed.
30. This Order does not waive, suspend or amend any regulations promulgated by the State, including those under the authority of the Department of Alcoholic Beverage Control; nor does it suspend or supersede existing prohibitions against drinking in public and similar regulations pertaining to public consumption and possession of alcohol. Alcoholic beverages sold under this Order must be sold in containers that are fully sealed in a manner designed to prevent consumption without removal of the lid or cap.
31. Essential Businesses shall operate in accordance with all current local licenses or permits, including business licenses, health permits, and the like.

32. The City shall promptly provide copies of this Order by: (a) posting it on the Long Beach's Department of Health and Human Services website (<http://www.longbeach.gov/health/>), (b) posting it at the Civic Center located at 411 W. Ocean Blvd., Long Beach, CA 90802, (c) providing it to any member of the public requesting a copy, (d) issuing a press release to publicize the Order throughout the City, and (e) by serving via email on large facilities known to the Health Officer that are likely to be subject to this Order (but service via email is not required for compliance). The owner, manager, or operator of any facility that is likely to be impacted by this Order is strongly encouraged to post a copy of this Order onsite and to provide a copy to any member of the public requesting a copy.
  - a. The owner, manager, or operator of any facility that is likely to be impacted by this Order is strongly encouraged to post a copy of this Order onsite and to provide a copy to any member of the public requesting a copy.
  - b. Because guidance may change, the owner, manager, or operator of any facility that is subject to this Order is ordered to consult the Long Beach Department of Health and Human Services' website (<http://www.longbeach.gov/health/>) daily to identify any modifications to the Order and is required to comply with any updates until the Order is terminated.
33. If any section, subsection, sentence, clause, phrase, or word of this Order or any application of it to any person, structure, gathering, or circumstance is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, then such decision will not affect the validity of the remaining portions or applications of this Order.
34. This Order is also issued in light of the March 19, 2020 Order of the State Public Health Officer (the "Governor's Order") , which set baseline statewide restrictions on non-residential business activities effective until further notice, as well as the Governor's March 19, 2020 Executive Order N-33-20 directing California residents to follow the Governor's Order. The Governor's Order was complementary to the prior Safer at Home Order. This Order adopts in certain respects more stringent restrictions addressing the particular facts and circumstances in this City, which are necessary to control the public health emergency as it is evolving within the City and Los Angeles County. Without this tailored set of restrictions that further reduces the number of interactions between persons, scientific evidence indicates that the public health crisis in the City will worsen to the point at which it may overtake available health care resources within the City and increase the death rate. Also, this Order enumerates additional restrictions on non-work-related travel not covered by the Governor's Order, including limiting such travel to performance of Essential Activities; sets forth mandatory Physical Distancing Measures for all individuals in the City when engaged in activities outside their residences; and adds a mechanism to ensure that Essential Businesses comply with the Physical Distancing Measures.
35. Where a conflict exists between this Order and any state public health order related to the COVID-19 pandemic, the most restrictive provision controls. Consistent with California Health and Safety Code section 131080 and the Health Officer Practice Guide


for Communicable Disease Control in California, except where the State Health Officer may issue an order expressly directed at this Order and based on a finding that a provision of this Order constitutes a menace to public health, any more restrictive measures in this Order continue to apply and control in this City.

36. This Order is issued in accordance with, and incorporates by reference, the March 4, 2020 Proclamation of a State of Emergency issued by Governor Gavin Newsom and the and the March 4, 2020 Proclamation of Local Emergency by the City Manager, and the Declaration of Local Health Emergency by the Health Officer, ratified by the City Council on March 10, 2020, respectively, and guidance issued by the California Department of Public Health, as each of them have been and may be supplemented.
37. The Water Department, in consultation with the City Attorney, is permitted to shut off water service to businesses operating in violation of the order, as appropriate.
38. The entities subject to this Order that are not required to close may otherwise remain open for business and perform essential functions and operations during the duration of this Order under the condition that entities adhere to this Order any state public health order related to the COVID-19 pandemic. Entities permitted to remain open for businesses that do not adhere to this Order may be subject to mandatory closure for the duration of this Order, including any amendment or extension hereto. This Section shall not apply to the Long Beach Airport, or any business identified as federal critical infrastructure therein.
39. Failure to comply with any of the provisions of this Order constitutes an imminent threat and menace to public health, constitutes a public nuisance, and is punishable by fine, imprisonment, or both. To protect the public's health, the Health Officer of the City of Long Beach may take additional action(s) for failure to comply with this Order. Violation of this Order is a misdemeanor punishable by imprisonment, fine or both under California Health and Safety Code Section 120275 et seq and Chapter 1.32 of the Long Beach Municipal Code.

Pursuant to Long Beach City Charter Section 109, Sections 8634 and 41601 of the California Government Code; Sections 101040 and 120175 of the California Health and Safety Code; and Chapters 8.08 and 8.26 of the Long Beach Municipal Code, these Orders and Directives as issued by the Health Officer shall be enforceable by the Chief of Police of the City of Long Beach to ensure compliance with and enforcement of this Order and the Directives set forth herein.

Further, and in addition to the criminal penalties set forth herein, these Orders and Directives as issued by the Health Officer shall be enforceable by the City Manager of the City of Long Beach. For the duration of the declared health emergency, the City Manager is permitted to designate and authorize appropriate employees of the City to issue Administrative Citations and levy civil fines and penalties to those individuals, businesses, and others who are in violation of the Orders and Directives contained herein in accordance with the provisions of Chapter 9.65 of the Long Beach Municipal Code.

### PROMULGATION OF EMERGENCY REGULATIONS

As Director of Civil Defense for the City of Long Beach pursuant to Long Beach Municipal Code ("LBMC") section 2.69.060.A, and in accordance with the provisions of LBMC Chapter 8.120, I am authorized to promulgate regulations for the protection of life and property as affected by the COVID-19 emergency pursuant to Government Code section 8634, and LBMC sections 2.69.070.A and 8.120.020. The following shall be in effect for the duration of the Long Beach Health Order, SAFER AT HOME ORDER FOR CONTROL OF COVID-19, issued above, which is incorporated in its entirety by reference:

The Long Beach Health Officer Order, SAFER AT HOME ORDER FOR CONTROL OF COVID-19, shall be promulgated as a regulation for the protection of life and property.

Any person who, after notice, knowingly and willfully violates or refuses or neglects to conform to the above referenced lawfully issued Health Order shall be guilty of a misdemeanor punishable by a fine not to exceed one thousand dollars (\$1,000), by imprisonment for a period not exceeding six (6) months, or by both such fine and imprisonment. (Long Beach Municipal Code sections 8.120.030.A and 8.120.030.E.3.)

### **MEASURES TO PREVENT CROWDS FROM GATHERING (check all that apply to the facility):**
