### SECOND AMENDMENT TO AGREEMENT NO. 34173

THIS SECOND AMENDMENT TO AGREEMENT NO. 34173 is made and entered, in duplicate, as of November 11, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 23, 2019, by and between PADILLA & ASSOCIATES, INC., a California corporation ("Consultant"), with a place of business at 211 East City Place Drive, Santa Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34173 (the "Agreement") whereby Consultant agreed to provide as-needed professional compliance monitoring services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$70,000 for a total not to exceed amount of \$270,000; and

WHEREAS, the Parties informally added \$158,075 to the Agreement; and WHEREAS, the Parties desire to add \$20,000 for a total not to exceed amount of \$448,075, inclusive of all amounts referenced above, extend the term to November 14, 2020 and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Four Hundred Forty-Eight Thousand Seventy-Five Dollars (\$448,075), at the rates or charges shown in Exhibit "B"."
  - 2. Section 2 of the Agreement is hereby amended to read as follows:
  - "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on
