Hi, my name is Allison and I'm a resident of Council District 2. I was born and raised in Long Beach. This city is an amazing place to live, but I am astonished at the ineptitude of our local government to listen to their constituents. Specifically, I want to express how inadequate the action of our city council is in relation to the protestor's demands in Long Beach. To be clear, protestors want an immediate divestment from the police and investment in Black communities. Long Beach allocated almost 240 million dollars for policing in 2019, then spent additional money fighting lawsuits raised by victims of police brutality. Those funds should be immediately reallocated to healthcare, housing, and education.

Even without a racial lens applied to the LBPD, there is a serious history of abuse of power that has not been reconciled or addressed. In 2016, a judge reprimanded the department for discriminatory sting operations targeting gay men. Also in 2016, LBPD was ranked 5th in the nation for use of force. In 2018, it was revealed that LBPD installed the Tiger Text app, allowing them to collude on cases with impunity as those messages were never added to the official case file. Also in 2018, LBPD destroyed 23 years of personnel records rather than have them be subject to new transparency laws. In 2019, the city spent over 8 million dollars on police-related lawsuits. And in 2020, in response to protestors, LBPD glorified violence on social media and shot peaceful protestors and press, causing severe injuries to individuals. I'm unclear as to who the police in Long Beach are protecting, but it's not the community. These recent events show a clear pattern of poor leadership and decision making, even without the statistics that identify the clear racial bias and profiling underway.

The solution here is clear. We don't need reforms to the system, we need a dramatically different one. A new system that supports and uplifts its community. You've seen (and will see) photos and videos clearly detailing demands from sustained protests with no sign of slowing down. You don't need a formal listening period. Our message is loud and clear. Defund the police.
