1 FIRST AMENDMENT TO CONTRACT NO. 35081

3 THIS FIRST AMENDMENT TO CONTRACT NO. 35081 is made and
4 entered, in duplicate, as of May 7, 2020 for reference purposes only, pursuant to Resolution
5 No. RES-18-0077, adopted by the City Council of the City of Long Beach at its meeting on
6 June 12, 2018, by and between NATURAL GAS SOLUTIONS NORTH AMERICA, LLC, a
7 Delaware limited liability company, as successor to DRESSER, LLC ("Contractor"), with a
8 place of business at 16240 Port Northwest Drive, Suite 100, Houston, Texas 77041, and
9 the CITY OF LONG BEACH ("City"), a municipal corporation.

10 WHEREAS, as authorized by Resolution No. RES-18-0077, City and
11 Contractor (the "Parties") entered into Contract No. 35081 (the "Contract") whereby
12 Contractor agreed to provide gas meters and related services and parts; and

13 WHEREAS, the Parties desire to extend the term one (1) additional one-year
14 period and clarify the authorized annual amount;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 2 of the Contract is hereby amended to read as follows:

18 "2. City shall pay Contractor in due course of payments, following receipt
19 of an invoice from Contractor and upon acceptance from City, for gas meters and related
20 services and parts, the prices shown in Exhibit "A", a sum not to exceed Three Hundred
21 Thousand Dollars (\$300,000) annually for a period of two (2) years, with the option to renew
22 for two (2) additional one (1) year periods."

23 2. Section 3 of the Contract is hereby amended to read as follows:

24 "3. The term of this Contract shall commence on August 1, 2018, and
25 shall terminate at midnight on July 31, 2021 unless sooner terminated as provided herein.
26 The City may terminate this Contract by giving thirty (30) days prior notice of termination
27 to Contractor."

28 3. Except as expressly modified herein, all of the terms and conditions


