THIRD AMENDMENT TO AGREEMENT NO. 33846

THIS THIRD AMENDMENT TO AGREEMENT NO. 33846 is made and entered, in duplicate, as of April 22, 2020 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 21, 2020, by and between ITERIS, INC., a Delaware corporation ("Consultant"), with a place of business at 1700 Carnegie Avenue, Suite 100, Santa Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33846 (the "Agreement") whereby Consultant agreed to provide as-needed traffic engineering, transportation planning and related technical and professional services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to May 31, 2019; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the amount by \$100,000 for a total not to exceed amount of \$700,000 and extend the term to May 31, 2020; and

WHEREAS, the Parties desire to add \$400,000 to the Agreement for a total not to exceed amount of \$1,100,000 and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million One Hundred Thousand Dollars (\$1,100,000), at the rates or charges shown in Exhibit "B"."
