THIRD AMENDMENT TO AGREEMENT NO. 34352

THIS THIRD AMENDMENT TO AGREEMENT NO. 34352 is made and entered, in duplicate, as of March 19, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 10, 2020, by and between UNITED STORM WATER, INC., a California corporation ("Contractor"), with a place of business at 14000 E. Valley Boulevard, City of Industry, California 91746, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34352 (the "Agreement") whereby Contractor agreed to provide storm drain routine maintenance and repair; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add a one-time amount of \$710,000 to cover the many emergency storm calls that took place December 2016 to February 2017; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to July 31, 2020 and add the annual agreement amount plus contingency; and

WHEREAS, the Parties desire to add \$1,269,045 to the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
- "A. Contractor shall furnish specialized services more particularly described in Exhibit "B", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an annual amount not to exceed Two Hundred Seventy-Six Thousand Dollars (\$276,000) plus a contingency amount of Sixty-Nine Thousand Dollars (\$69,000), at the rates or charges shown in Exhibit "B"; plus, an additional amount of Seven Hundred Ten Thousand Dollars (\$710,000)

 Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34352 are ratified and confirmed and shall remain in full force and effect.
