#### **EXAMPLES OF DUTIES:**

Under general supervision, performs semi-skilled construction and repair work on gas pipelines and related facilities; sets up and operates tapping and pressure control equipment; installs valves, clamps and fittings; greases plug valves; operates combustible gas indicator, "Holiday" detector, pipe locator, soil reads and similar devices; bends and threads pipes; prepares and applies pipe protective coatings in field and shop; operates, oils, cleans and makes minor repairs to assigned departmental equipment such as earth boring equipment, pneumatic tools, compressors, etc.; works as a skilled trades helper; observes safety rules and regulations; may be assigned to cleaning and painting meters, regulators and related apparatus in field and shop; may drive vehicles transporting crews and equipment; and performs other related duties as required.

#### **REQUIREMENTS TO FILE:**

One year paid, full time equivalent (2088 hours) experience in the construction, maintenance, or repair of natural gas or oil pipeline systems or closely related work that requires experience in the operation of earth borers, electronic pipe locators, pipe tapping machines, any other pipe related tools/equipment, or other similar construction equipment.

#### **KNOWLEDGE SKILLS AND ABILITIES:**

- Ability to:
  - Regularly lift to 60 pounds and perform strenuous manual labor on a daily basis (dig by hand, operate jackhammers, etc.).
  - Exercise good judgment, tact, and initiative when dealing with the public.
- Willingness to work an alternative work schedule and standby rotation, weekends, holiday and overtime hours as required.

Comply with the Anti-Drug and Alcohol Misuse Prevention Program as required by the U.S. Department of Transportation regulations on an ongoing basis.

Comply with the Energy Resource Department Operator Qualification Program based on department standards and maintain qualification(s) on an ongoing basis A valid driver's license and a current DMV driving record must be submitted to the hiring department at the time of selection.

Successful candidates who are selected for the position will be required to obtain a valid California Class A driver license prior to passing probation.

#### **DESIRABLE QUALIFICATIONS:**

Experience with heat fusion-type plastic piping for natural gas pipeline systems; a valid California Class A driver license; a Transportation Worker Identification Card (T.W.I.C) may be desirable for some positions.

**EXAMPLES OF DUTIES:**

**Transportation Planning:**

Conducts or reviews traffic analyses prepared by consultants for Port facilities, rail, highway, and other transportation related projects; assists with the planning of roadway and rail facilities within the Port; collects and develops various types of data for use in Port transportation studies and annual Port Emissions Inventories; monitors budgets for the on call transportation services contracts; evaluates and develops strategies on funding issues including the identification of organizational partners and collaborators; represents the Port at outside agency meetings and coordinates with these agencies on behalf of Port interests while also balancing regional needs; prepares and maintains progress reports and financial plans for major capital grant funded transportation projects in the Port; may collect and analyze economic data related to Harbor District oil operations and facility requirements; may provide training and supervision to lower level staff, and performs other duties as required.

**Master Planning – Land Use; Master Planning – Economics:**

Collects and analyzes land use and economic data for forecasting cargo flows and projecting Port land and facility requirements; monitors trends in international trade patterns, trade services, maritime technology, Port development, inland transportation and shipper logistics; works with and manages consultants and assists in primary and secondary data collection for the preparation of market studies, economic impact analyses of Port and oil facilities, land use plans, and facility and master plans; collects information on terminal throughput, and maintains graphic and mapped material to facilitate the preparation of descriptive and analytical studies; coordinates with other Port, City, and agency staff in the collection and maintenance of economic, oil field, and land use information; assists in the preparation and presentation of forecasts, study findings and plan recommendations.

**REQUIREMENTS TO FILE:**

Applicants must meet **OPTION A OR B:**

A. Bachelor's degree from an accredited college or university in Urban Planning, Regional Planning, Regional Science, Civil Engineering, Transportation Engineering, Transportation Economics, Micro Economics, Geography, Business, or closely related field (**proof required**)\* **AND** a minimum of two years paid, fulltime equivalent work experience or a paid, fulltime equivalent internship in land use, regional, transportation planning, economics, traffic engineering, business analysis, technical forecasting or logistics;

**OR**

B. Master's Degree or Doctorate's Degree in a closely related field **(proof required)\***  
**AND** a minimum of one year paid, fulltime equivalent work experience or a paid, fulltime equivalent internship in land use, regional, coastal, transportation planning, economics, business analysis, technical forecasting or logistics;

#### **Additional Requirements to File**

- Willingness to work irregular hours, weekends, evenings, overtime and holidays as needed.
- A valid motor vehicle operator's license and current DMV driving record must be submitted to the hiring department at the time of selection.

**\*Required documents must be uploaded to the online application at the time of filing. Any proofs submitted must contain either the applicant's name or other identifying characteristic on the form. Candidates who possess degrees from colleges or universities from outside the United States must attach proof of educational equivalency.**
