Request for Permanent Assignment to Former Classification Form (Revert)

PURPOSE:

To request permanent assignment to former classification for an employee.

RELEVANT RULES AND REGULATIONS/POLICY:

Civil Service Rules and Regulations Section 67 (1):

"Permanent assignment to a position in a classification from a position in another classification shall be contingent on the approval of the appointing authority, the heads of the departments involved, and the approval of the Commission and shall be accomplished in accordance with this section. An employee may be permanently assigned to:

(1) A former classification in which he/she held permanent status if requested by the employee, or involuntarily to a former or lower classification for disciplinary reasons pursuant to Article VII of these rules. An employee involuntarily demoted to a lower classification shall not serve a probationary period."

PROCESS:

- Requesting department should contact Civil Service Deputy Director to determine if the request is needed.
- Requesting department completes Request for Permanent Assignment to Former Classification Form.
 - The requesting department completes Section I of this form. Civil Service completes Section II of this form.
- Request Form emailed to Civil Service Department Executive Assistant
- Request will be placed on the agenda for the upcoming Commission meeting.
- At Commission meeting, department is present to address questions from the Commission.
- Commission Approves/Denies request.

Subject: REQUEST FOR PERMANENT ASSIGNMENT TO FORMER CLASSIFICATION-CONSTRUCTION INSPECTOR II AND TRANSFER—FERMIN GRACIAN

In accordance with Civil Service Rules and Regulations, Article VI, Section 67(1), the Department of Water requests the approval to appoint Mr. Fermin Gracian to his former permanent position of Construction Inspector II.

Facts for Consideration:

- On July 27, 2020, the Civil Service Department received correspondence from Christopher J. Garner, General Manager of the Water Department requesting the approval to appoint Mr. Fermin Gracian to a position in the classification of Construction Inspector II where Mr. Gracian previously held permanent status.
- Mr. Gracian began his City career in the Energy Resources Department where he held a variety of positions culminating in his appointment as a Gas Maintenance Supervisor on 12/23/17. He obtained permanent status as a Gas Maintenance Supervisor on July 23, 2018.
- On January 5, 2019 Mr. Fermin Gracian accepted a position in the Water Department as a Construction Inspector II and subsequently passed probation in this classification on July 14, 2019.
- On March 28, 2020 Mr. Gracian was reappointed to his former classification of Gas Maintenance Supervisor I with the Department of Energy Resources. This request was approved by Commission on February 19,2020.
- On July 17, 2020, Mr. Fermin Gracian contacted the Water Department requesting to revert to his former classification of Construction Inspector II position. The Water Department supports this request.
- Mr. Gracian has been notified of impact of his Civil Service rights and referred to the Human Resources Department regarding salary, benefits, department status and working conditions.
- The Energy Resources Department has been made aware of Mr. Fermin Gracian request to transfer back to the Water Department in his former classification of Construction Inspector II and has no reservations with this request.
- Civil Service currently has one (1) eligible list for the classification of Construction Inspector, which is expiring on December 10, 2020.
- The Water Department currently has one (1) requisition on file with the Civil Service Department. The requisition # W20-40 was received on July 16, 2020 in the Civil Service Department. Requisition W20-40 will be utilized to

place the employee in the classification of Construction Inspector, if approved by the Commission.

RECOMMENDATION:

Civil Service staff has reviewed the supporting documentation from the Water Department and recommends the approval of Mr. Fermin Gracian's request to be permanently assigned to his former classification of Construction Inspector II and transfer with the Water Department.

Subject: Request for Permanent Reassignment to Former Classification – Fermin Gracian

The Water Department respectfully requests that the Commission grant a permanent assignment for Fermin Gracian, Gas Maintenance Supervisor I, to his former classification of Construction Inspector II in accordance with Article VI, Section 67 (1) of the Civil Service Rules and Regulations.

Mr. Gracian became a Construction Inspector II with the Long Beach Water Department effective January 5, 2019, and obtained permanent status in this classification on July 14, 2019.
