WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 31, 2018 and attach a revised scope of work; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to July 31, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to amend certain terms and extend the term to July 31, 2020; and

WHEREAS, the Parties desire to exercise their final option to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on August 1, 2014, and shall terminate at 11:59 p.m. on July 31, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33533 are ratified and confirmed and shall remain in full force
