

SECOND AMENDMENT TO CONTRACT NO. 34600

34600

THIS SECOND AMENDMENT TO CONTRACT NO. 34600 is made and entered, in duplicate, as of May 7, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on March 27, 2017, by and between MCNEILUS FINANCIAL, INC., DBA MCNEILUS TRUCK AND MANUFACTURING COMPANY, a Texas corporation ("Contractor"), with a place of business at 524 E. Highway St., Dodge Center, MN, 55927, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City entered into Contract No. 34600 ("Contract") with Contractor to provide replacement parts for the repair and maintenance of the City's McNeilus refuse collection trucks; and

WHEREAS, the parties entered into a First Amendment to the Contract to extend the term of the Contract for one (1) additional year; and

WHEREAS, the parties wish to exercise their second and last option to extend the term of the Contract for one (1) additional year; and

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 3 of Contract No. 34600 is hereby amended to read as follows:

"3. The term of this Contract shall be deemed to have commenced on May 1, 2017, and shall terminate at midnight on April 30, 2021, unless sooner terminated as provided in this Contract."

Except as expressly modified herein, all of the terms and conditions contained in Contract No. 34600 are ratified and confirmed and shall remain in full force and effect.


