FOURTH AMENDMENT TO AGREEMENT NO. 34122

THIS FOURTH AMENDMENT TO AGREEMENT NO. 34122 is made and entered, in duplicate, as of July 14, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 23, 2019, by and between COMPREHENSIVE HOUSING SERVICES, INC., a California corporation ("Consultant"), with a place of business at 8840 Warner Avenue, #203, Fountain Valley, California 92708, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34122 (the "Agreement") whereby Consultant agreed to provide as-needed professional compliance monitoring services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$130,000 for a total not to exceed amount of \$370,000 and extend the term to November 14, 2019; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$201,000 for a total not to exceed amount of \$571,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$100,000 for a total not to exceed amount of \$671,000 and extend the term to November 14, 2020; and

WHEREAS, the Parties desire to add \$40,000 to the Agreement

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Seven Hundred Eleven

Thousand Dollars (\$711,000), at the rates or charges shown in Exhibit "B"."

 Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34122 are ratified and confirmed and shall remain in full force and effect.
