# LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY CONTRACT NO. PS95866000LBPD24750, MODIFICATION NO. 2

#### FOR: TRANSIT LAW ENFORCEMENT SERVICES

This Contract Modification No. 2 to Contract No. PS95866000LBPD24750 effective October 1, 2019, by and between the LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY, hereinafter referred to as "METRO", and City of Long Beach through Long Beach Police Department (LBPD), hereinafter referred to as the "CONTRACTOR."

WHEREAS, Contractor and Metro entered into Contract No. PS5862300LBPD24750 (previous contract number), effective March 23, 2017, subsequently modified by Modification No. 1, effective January 8, 2018 (the "Existing Contract) and;

WHEREAS, Contractor and METRO desire to amend the Existing Contract as provided herein;

Now, therefore, it is mutually agreed, by and between the parties as follows:

#### 1. EXHIBIT B – Memorandum of Costs

Delete Exhibit B - Memorandum of Costs in its entirety and substitute in lieu thereof, Exhibit B - Memorandum of Costs revised as of October 1, 2019, pages 13 thru 15b, attached hereto and incorporated herein by this reference and made an integral part hereof.

All other terms and conditions of Contract No. PS95866000LBPD24750shall remain unchanged.

Amendment revisions are identified by a denoted bar (I) in the border and are printed in bold and italics for easy reference.

Except as expressly modified hereby, the Existing Contract, as modified remains in full force and effect as originally executed.

#### **EXHIBIT B - MEMORANDUM OF COSTS**

Ninety (90) days prior to the start of each fiscal year, Contractor shall submit for approval of LACMTA, a list of **estimated** maximum fully burdened hourly rates per labor classification, together with the necessary documentation in support of the proposed rates [e.g. applicable MOUs with labor unions, current payroll records, **etc.**indirect cost rates, and a breakdown of estimated overhead costs).

## A. Maximum Fully Burdened Hourly Rates

The **estimated** maximum fully burdened hourly rate for each labor classification, shall be **the** sum of the following:

### 1. Sworn Personnel (field personnel)

Sworn field personnel shall primarily be assigned to this contract on an overtime basis.

The maximum hourly direct labor rate (overtime) for each labor classification [per Memorandum of Understanding (MOU) with the respective labor unions] that will be deployed under this Contract.

Overtime rates shall be in accordance with guidelines provided in the respective MOUs of each labor union.

#### **Indirect Overhead Cost**

Indirect Overhead Cost shall be computed as follows:

Hourly Direct Labor Rate per labor classification
 Indirect Overhead Rate not-to-exceed 25%

The indirect overhead rate of sworn/civilian personnel shall be based on the indirect overhead rate in effect at the time the work was performed. This rate may change annually and shall be applied prospectively.

Other Direct Equipment/Supplies Overhead Cost shall be estimated computed as follows:

In no case shall actual fully burdened hourly rate billed for each personnel be greater than the maximum fully burdened hourly rate set per labor classification, for each applicable period.

#### 2. <u>Management/Field Supervisory and Administrative Personnel</u>

deployed under this Contract.

Indirect Overhead Cost Indirect Overhead cost shall be computed as follows:

= Hourly Direct Labor Rate x Indirect Overhead Rate

The indirect overhead rate of sworn/civilian personnel shall be based on the overhead rate in effect at the time the work was performed. This rate may change applied prospectively.

General and Administrative Cost (Indirect Overhead) General & Administrative Cost shall be computed as follows:

= (Total Direct Labor Cost + Other Direct Cost) x G&A Rate not-to-exceed 25%

In no case shall actual fully burdened hourly rate billed for each personnel be greater than the maximum fully burdened hourly rate set per labor classification, for each applicable period.

## B. K-9 Explosive Detection

Contractor shall provide K-9 Explosive Detection services on an on-call overtime basis. All call-outs will be billed for a minimum of two hours based on the current Police Officers' Association labor contract.

## C. Salary Escalation on Direct Labor Rates

Direct labor rates of Contractor personnel shall be adjusted annually in accordance with the terms of the MOU with the respective labor unions. Salary rate adjustments shall subject to annual limits:

#### D. Transition Costs/Mobilization

LACMTA agrees to pay Transition/Mobilization Costs articulated in Exhibit A and the Limited Notice to Proceed (Exhibit E), covering the period of March 23, 2017, through June 30, 2017.

## E. Invoicing

Invoices shall be based on actual services performed, in accordance with the agreed-upon deployment plan/schedule. In no case shall billing rate for each personnel exceed the maximum fully burdened rate set for each labor classification.
