FIRST AMENDMENT TO AGREEMENT NO. 35523

THIS FIRST AMENDMENT TO AGREEMENT NO. 35523 is made and entered, in duplicate, as of September 22, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on August 4, 2020, by and between JARVIS, FAY & GIBSON, LLP ("Special Counsel") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Special Counsel (the "Parties") entered into Agreement No. 35523 whereby Special Council agreed to provide legal services in the *Diana Lejins;* Angela Kimball v City of Long Beach matter; and

WHEREAS, the Parties desire to add \$100,000 to the Agreement;

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, the Parties agree as follows:

- 1. Section 3 of Agreement No. 35523 is hereby amended to read as follows:
- "3. <u>FEE</u>. City shall pay to Special Counsel in due course of payments compensation at the hourly rates identified in the staffing profile and reimbursement of costs as further described herein and in the "Guidelines" also attached hereto, in a total not-to-exceed amount of Four Hundred Thousand Dollars (\$400,000) (including funds already expended). The "not-to-exceed" amount may be subsequently modified or changed after a written budget has been submitted to, and approved by the City Attorney pursuant to Section 7 of this Agreement. Any new "not-to-exceed" amount shall be set forth in a written amendment signed by both parties."
- 2. Except as expressly amended herein, all terms and conditions in Agreement No. 35523 are ratified and confirmed and shall remain in full force and effect.
