WHEREAS, the Parties desire to extend the term one (1) additional one year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 2 of the Agreement is hereby amended to read as follows.
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2021, unless sooner terminated or extended as provided in this Agreement, or unless the services are completed sooner. The term may be extended for one (1) additional one-year period at the discretion of the City Manager."
