When I was cleaning graffiti downtown in the early morning after the looting with hundreds of others, two things were abundantly clear. First, Long Beach is full of amazing, kind, and dedicated people. Second, we need to do a better job at listening to those who aren't always heard. The IRC is a unique opportunity to make sure that none of our voices are unheard and that none of our interests are overlooked.

I believe that my background makes me a strong candidate for the IRC. I have both a bachelors (JMU, 2014) and masters (UCI, 2019) degree in Political Science. In school, my research- primarily focusing on Race, Ethnicity & Gender and Political Psychology- has given me a strong foundation in both qualitative and quantitative analysis. My training has made me academically literate and prepared me to understand complex political concepts.

Throughout graduate school, it was important for me to stay involved in the Long Beach community. I have volunteered with the LGBTQ Center of Long Beach for several years, most notably as a committee member for the 2017, 2018, and 2019 AIDS Walk. This has given me ample experience working with a diverse group of people towards a common goal as well as a unique and valuable understanding of the greater Long Beach community.

There is a lot of work to be done. Making sure that our representatives fairly reflect who we are is surely the best place to start.

I have been a homeowner and resident of Long Beach for over twenty-seven years. I am a resident of the city's first historic district and have been involved in the HIV planning process since its inception in the mid-90's. This has given me the opportunities to work with local community-based organizations, the City's health department and local populations impacted by crime, drug addiction, homelessness, port pollution, infectious diseases, redevelopment and port pollution. I have worked with the city's Spanish speaking population, the Cambodian diaspora, and the LGBTQ community. Because my husband and I are a one-car family and I work in the city, I have gained a street-level connection to my city's fellow residents, biking Long Beach neighborhoods, from three industrial West side, to their environs around Cal State Long Beach, three downtown tourist spots to the north Long Beach neighborhoods.

In addition to my employment at an FQHC, volunteer work at three Long Beach LGBTQ Center, I also co-chair the HIV Community Planning Group, which has provided me with the experience of working collaboratively across populations and building consensus.

The City of Long Beach continues to thrive as a model city that other city's look to in bringing non-elected citizens into the process of open governing. I want to be a vessel that assists all districts in fair, open representation and elections through this commission. Second, given my experience as a professor at several universities, including Long Beach State, and high-level human resource executive experience, and a Ph.D., I have the strong analytical skills necessary to evaluate data, disseminate research, and draw up impartial conclusions and recommendations. Given this experience, I have a sincere appreciation for all persons and the beautiful diversity the city of Long Beach has based on its geographic, demographic, and political makeup.

On that note, my experience as a professor and practitioner has no doubt provided me the opportunity to work cooperatively with others. I'm a great communicator and listener and ensure all persons have a seat at the table. This is applied in my current situation with students, faculty, administrators, and those business owners I provide HR services to.

As a local business owner, I have provided human resource consulting to several businesses throughout the city of Long Beach, including the majority of its districts and neighborhoods.
