

FOURTH AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00036

THIS FOURTH AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00036

is made and entered, in duplicate, as of May 6, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 5, 2020, by and between AECOM TECHNICAL SERVICES, INC., a California corporation ("Permittee") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City granted Permittee permission to enter the City-owned property described in Exhibit "A" attached to Permit No. P-00036 (the "Permit") for the purpose and to the extent reasonably necessary for the drilling of soil vapor sampling wells and the installation of temporary vapor testing equipment in the Baker Street Mini Park and the Wrigley Heights Dog Park; and

WHEREAS, City and Permittee entered into a First Amendment to the Permit to extend the term for a one (1) year period through April 30, 2017; and

WHEREAS, City and Permittee entered into a Second Amendment to the Permit to extend the term for an additional one (1) year period through April 30, 2018; and

WHEREAS, City and Permittee entered into a Third Amendment to the Permit to further extend the term for a two (2) year period through April 30, 2020; and

WHEREAS, City and Permittee desire to extend the term for an additional two (2) year period with the option to renew for three (3) additional one-year periods for continued monitoring of the soil vapor sampling wells located in the Parks;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the parties agree as follows:

1. Section 3 of the Permit is hereby amended to read as follows:

"3. The term of this Permit shall begin on May 1, 2015, and shall end on April 30, 2022. City shall have the option to extend the term of this Agreement for three (3) additional one-year periods through April 30, 2025, at the discretion of the City Manager."

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. P-00036 are ratified and confirmed and shall remain in full force and effect.

Permittee consents to and agrees to perform the terms, covenants, and conditions imposed on Permittee under this Permit during the renewal period.
