To Whom It May Concern,

On behalf of my parents, James and Yvonne Stewart, and as the property manager, I met with both the tenant and the Code Enforcement Officer, Ramon Barajas, since the issuance of this citation. There was clearly misunderstanding of the expectation and next steps given this COVID-19 environment that we find ourselves in.

I was under the impression that next steps were pending relaxed COVID restrictions which would allow me to be included on the specific expectation to be cured.

In my recent discussion with Mr. Barajas, I also explained that the shut down of the government offices has left navigation from the customer's perspective challenging to move through.

As for the tenant, his focus was on correcting the violations that he had control over. Mr. Barajas last visit on Sept. 11, 2020 confirmed that the previous instructions over placement and removal of equipment had been followed and the only issue left outstanding is the most cumbersome one; securing proper permits.

He has also shared with me that COVID-19 has impacted his employment situation significantly so the permit costs have also been a factor.

I am asking that this fine be stayed from this date until December 2020 or until two weeks after the City Offices re-open; given that permits are heavily delayed at this time.

Thank you for reading and considering these unique circumstances given this unique time we all find ourselves in.
