On Wednesday January 6th, 2021, the day during which a Joint Session of the United States Congress was to procedurally certify our presidential election, I found myself fearing for my safety, the safety of my colleagues, and the security of our democracy.

As the duly elected Representative for California's 47th Congressional District, I strongly condemn the insurrection that took place, threatening my own life and the lives of thousands of innocent people. I, therefore, wholeheartedly support agenda item 28, a discussion regarding the City taking a position to condemn the attack on the Capitol, and respectfully encourage the Council to join me in denouncing the violence enacted by domestic terrorists and those who incited the assault against our democracy.

I would also like to acknowledge the subsequent passing of Capitol Police Officer Howard Liebengood who dedicated his life to protecting the halls of the Senate. It is with their sacrifices in mind that I believe, now, more than ever, we must stand united for our institutions and republic at every level of government.
