



Addendum to City of Long Beach Managed Print Service Contract

This Addendum to the City of Long Beach Managed Print Services contact ("Addendum") is entered into between the City of Long Beach and Sharp Electronics Corporation and is effective 1/1/2021 through 12/31/2021.

This addendum modifies the pricing originally agreed to in the Managed Print Services contract. Under this new Addendum, Sharp will honor the 60 month payment quotes in the original contract, for newly agreed upon lease terms signed and agreed upon that are either 48 months in length or 59 months in length, for products placed and funded in the calendar year 2021.

The goal of this addendum is to provide the departments throughout the City of Long Beach with the low price point of the 60 month term, and still allow new lease terms within 2021 when the original contract will end.

Service pricing remains unchanged.

The addendum will expire on 1/1/2022.
