APPROVAL OF MINUTES

1. 21-001BH Recommendation to approve the minutes of the Board of Health and Human Services meetings held Friday, December 18, 2020.

There was no public comment.

EXECUTIVE STAFF REPORTS

2. 21-002BH Recommendation to receive, discuss and file a report from the Director of Health and Human Services.

Kelly Colopy, Director of Health and Human Services, provided the Board with

an update on the following:

- The City, through Project Homekey, opened an isolation and quarantine site providing 33 beds for individuals experiencing homelessness.
- The City is moving forward on the creation of a Homeless Navigation Center. The center will provide shelter for homeless youth, as well as storage for personal belongings.
- Work on the Department's North Facility Center continues. The Center was closed in 2019 and is undertaking a complete remodel.
- The Youth Strategic Plan is scheduled to go to the City Council on February 9, 2021.
- The Department's Strategic Plan is scheduled to go to the City Council in March/April 2021.

This BH-Agenda Item was approve recommendation.

3. 21-003BH

Recommendation to receive, discuss and file a report from the City Health Officer on Communicable Disease Control activities.

Dr. Anissa Davis, City Health Officer, provided the Board with an update on the following:

- An upcoming UCLA study on the effectiveness of integrating opioid, HIV/STI and Hep C treatment from a mobile unit.
- A presentation she gave on Sexual Orientation and Gender Identity in cases resulting in death from COVID-19.
- Informed the Board that Belinda Prado, who had left the Health Department's employment several months ago, would be returning to the Department and her work leading HIV/STD Surveillance.

This BH-Agenda Item was approve recommendation.

REGULAR AGENDA

4. 21-004BH Recommendation to receive an update regarding the Department's COVID-19 activities.
- Cases in Long Beach have currently reached a plateau. The City's case count peaked on December 31, 2020, with 1,067 cases reported on one single day. Currently cases are running at approximately 600 new cases per-day.
 - Local mortuaries have requested an expansion to the Vital Records office hours to keep up with the increased workload. To date there have been over 500 deaths reported in Long Beach, with a peak of 54 deaths in one day.
 - A brief discussion ensued regarding the criteria for reopening schools.
 - A brief discussion ensued regarding hospital capacity and case rates.
 - Vaccinations provided to over 15,000 individuals to date. A brief discussion ensued regarding vaccine distribution and the issues encountered related to vaccination scheduling. Dr. Davis mentioned that mobile vaccination clinics are also being planned for the future.
 - A brief discussion ensued regarding the need for a public relations campaign directed towards counteracting the negative messaging circulation around the COVID-19 vaccine.

This BH-Agenda Item was approve recommendation.

5. 21-005BH Recommendation to receive and file a presentation from the Youth Leaders for Tobacco Control.
- Maria Garcia, Community Worker for the Tobacco Education Program, introduced the Youth Leaders for Tobacco Control who provided a presentation on E-Cigarettes and the effects they have on health in Long Beach, a copy of which was received and filed as part of the permanent record, and responded to questions from the Board. The presentation discussed the various types of electronic nicotine delivery devices, the prevalence of flavors to enhance the appeal of such devices and the health effects and risks associated with their use.

Vice Chair St. Bernard suggested drafting a letter of support to be sent to the

Mayor and City Council, showing the Board's support of a permanent ban on flavored tobacco products and their support of the work being conducted through the Youth Leaders for Tobacco Control Program. Motion made by Board member Temple, seconded by Board member Curtis and approved unanimously.

This BH-Agenda Item was approve recommendation.

6. 21-006BH Recommendation to conduct the annual election of officers.

Vice Chair St. Bernard opened the floor to nominations for the Chair position. Boardmember Robson nominated Vice Chair St. Bernard to the position of Chair, seconded by Board member Ha. There being no other nominations, Vice Chair St. Bernard was unanimously elected to the position of Chair.

Vice Chair St. Bernard opened the floor to nominations for the Vice Chair position. Boardmember St. Bernard nominated Boardmember Susan Temple to the position of Vice Chair, seconded by Board member Mc. Neeley. There being no other nominations, Board member Temple was unanimously elected to the position of Vice Chair.

This BH-Agenda Item was approve recommendation.

7. 21-007BH Recommendation to discuss Board goals and infrastructure.

- Chair Smith briefly discussed the draft 2020 Board of Health and Human Services Annual Report and requested Board members to review the draft and provide their edits/input for discussion at the February 12, 2021 meeting.
- A brief discussion ensued regarding the Board's 2021 goals.
- A brief discussion ensued regarding vacant positions on the Board.

This BH-Agenda Item was approve recommendation.

8. 21-008BH Recommendation to discuss reimagining City support for the Health Department.

- Boardmember Temple indicated that she had met with Councilwoman Stacy Mungo in Council District 5.

This BH-Agenda Item was approve recommendation.

ONGOING BUSINESS

9. 21-009BH Recommendation to receive, discuss and file an update regarding the enforcement of the Health Order to wear masks in public.

Ms. Colopy indicated that the Health Department was working with other City departments on the enforcement of the City's masking order. More information will be available in the near future.

This BH-Agenda Item was approve recommendation.

10. 21-010BH Recommendation to receive and file an update on the status of the City's implementation of the legalization of cannabis.

Cannabis equity work is ongoing. Ms. Colopy will provide a more detailed update to the Board at the February 12th Board Meeting.

This BH-Agenda Item was approve recommendation.

11. 21-011BH Recommendation to receive and file an update on Community Hospital.

Community Hospital is currently open, providing 11 non-COVID ICU beds, and 40 additional ICU beds for overflow/surge capacity. Emergency Room services are not currently available at that facility but will be opening in the coming months.

This BH-Agenda Item was approve recommendation.

ANNOUNCEMENTS

Boardmember Temple announced that the Long Beach Unified School District will be holding a Human Trafficking Panel Discussion on January 28, 2021 in recognition of Human Trafficking Awareness Month.
