THIS FIRST AMENDMENT TO AGREEMENT NO. 35750 ("Amendment") is made and entered, in duplicate, as of December 23, 2020 ("Amendment Effective Date") for reference purposes only, pursuant to Resolution No. RES-20-0092, adopted by the City Council of the City of Long Beach at its meeting on August 4, 2020, by and between HEALTHVANA, INC., a Delaware corporation ("Contractor"), with a place of business at 7162 Beverly Blvd., #238, Los Angeles, CA 90036, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires COVID-19 test patient result reporting services; and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35750 (the "Agreement") whereby Contractor agreed to provide these services; and

WHEREAS, the Parties desire to extend the Agreement for another term and increase the contract amount; and

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 1.B of the Agreement is hereby amended to read as follows:

 - Section 2 of the Agreement is hereby amended to read as follows: 2.
- "2. TERM. The term of this Agreement shall commence on July 15, 2020 and shall terminate at midnight on January 31, 2022 unless sooner terminated as provided herein. City shall have the option to extend the term of this Agreement

for one (1) additional one-year period, at the discretion of the City Manager."
