- 2. The artists are not local, one is Australian and the other is from San Francisco. Muralists should come from Long Beach, or at least the LA Metro area.



About Askew One

Askew One/Elliot O'Donnell is a self-taught multi-disciplinary artist hailing from the capital of the South Pacific, Auckland, New Zealand. From his roots in his city's graffiti scene during the early 90's, he became one of the key figures known internationally from the region. He has been an integral part of the scene through organising Auckland's first graffiti festival, setting up multiple gallery spaces (Disrupt Gallery, Gallery With No Name and Studio 40) and publishing both a magazine (Disrupt Magazine) and book (InForm: New Zealand Graffiti Artists Discuss Their Work) showcasing New Zealand graffiti art. Additionally he has directed around 35 music videos for mostly hip hop artists.

Since 2010 Askew One has evolved his art practice into the Post-Graffiti realm, focusing on studio work and large scale outdoor murals. Askew One's focus has progressed from text and portraiture based paintings into a style he describes as 'portraiture by alternative means' that is part still life and part abstraction. He uses a combination of analogue and digital techniques to create compositions made from 3D scans of random objects and textures from the street. 

Dear Cultural Heritage Commission Members,

Our names are David Welch and Christine Votava. We are long-time residents of Bluff Heights Historic District in Long Beach. We are active members of our community, having volunteered for local PTAs, The Bembridge House, and the Bluff Heights Neighborhood Association.

We are writing to you to express our concern about the proposed mural project at 2800 East 4th Street on the corner of Temple Avenue and 4th Street. This location is on the northern border of Bluff Heights and the southern border of Rose Park, both historical neighborhoods. This location was formerly a much-loved neighborhood restaurant. It is now a cannabis dispensary.

The proposed mural project would paint two murals on the building. According to the proposal: "The East Village Arts District appeals to the artist in all of us, with it's avant-garde shops, galleries and restaurants... It is our intent to add to this beauty." The proposal also states that: "Retro Row, 4th Street, is where the vibrancy and creative spirit of Long Beach lives."

The issue we have with the proposal is that:

- 1) Bluff Heights is NOT the East Village Arts District
- 2) Bluff Heights is NOT Retro Row

The issue with these murals is one of APPROPRIATENESS. While they would look great on Retro Row or in the East Village, these murals are NOT appropriate for Bluff Heights.

The current façade of the building (tan and green) is perfectly appropriate for our historic neighborhood and should be preserved. It is highly inappropriate to paint avant-garde, urban themed murals in a historic neighborhood, even if the property is technically 'non-contributing'. The charm and overall aesthetic of our neighborhood would be adversely affected by these murals.

Neighbors of Bluff Heights have worked for many years to preserve the historic spirit and aesthetic of our neighborhood. We ourselves MUST curtail our more avant-garde instincts as it regards to our own properties. The same standards should be applied across the board.

We respectfully request that the Cultural Heritage Commission decline a Certificate of Appropriateness to the proposed mural project.

Regarding the proposed mural at The Lyft on 4th Street:

While my husband and I do not personally approve of the entire mural concept in historical neighborhoods, we understand many residents approve. So be it.

However, the mural with the young women with her breast exposed is completely inappropriate on a large neighborhood building. I am referring to the proposed 2800 E. 4th Street mural which is in the Bluff Heights neighborhood.

Our society has a growing awareness of the inappropriate sexualization of women's bodies for exploitation. I looked up the definition of exploitation and found the following: "Exploitation is the act of selfishly taking advantage of someone or a group of people in order to profit from them or otherwise benefit oneself." I believe that The Lyft is using a sexualized woman's body to benefit their own business interest. In my opinion, this mural has no relevant significance and it is insulting to all women and men who value equality and support social justice.

When I first saw the proposed mural on 4th Street, I immediately thought that this young woman is being **"groomed"** to accept that her body is not her own. While others may see that the artist had another purpose in mind, to me, this is a young woman, whose body is on display, for the sole purpose of exploitation. In fact, the artist, Amandalynn, in her bio, indicates that she "depicts strong, seductive women and illustrates their strength..." I just do not think a seductive woman belongs in public display.

I have never supported any level of art censorship. Art exhibited for individuals or in a museum adds such value to the human experience. However; art designed for public display should have a public value added. I submit that the proposed 4th Street mural does not meet any criteria of how public art should benefit society.

Another fact is that the mural colors of red, orange and purple, are not appropriate choices for our historic neighborhood. I understand that purple has significance for the cannabis community but are these colors the right colors for the historic neighborhood of Bluff Heights? I doubt that anyone in our community would be allowed to paint their home in any of these colors.

The main point needs to be reinforced. There is absolutely no way that our children, families, and our neighbors should walk or drive by a mural of a young woman being exploited in a large outdoor mural. Please vote to disallow the proposed mural at 2800 E. 4th Street.

I also question if The Lyft is proposing to change their name to 1 Lyfe as indicated in the proposal.

About Askew One

Askew One/Elliot O'Donnell is a self-taught multi-disciplinary artist hailing from the capital of the South Pacific, Auckland, New Zealand. From his roots in his city's graffiti scene during the early 90's, he became one of the key figures known internationally from the region. He has been an integral part of the scene through organising Auckland's first graffiti festival, setting up multiple gallery spaces (Disrupt Gallery, Gallery With No Name and Studio 40) and publishing both a magazine (Disrupt Magazine) and book (InForm: New Zealand Graffiti Artists Discuss Their Work) showcasing New Zealand graffiti art. Additionally he has directed around 35 music videos for mostly hip hop artists.

Since 2010 Askew One has evolved his art practice into the Post-Graffiti realm, focusing on studio work and large scale outdoor murals. Askew One's focus has progressed from text and portraiture based paintings into a style he describes as 'portraiture by alternative means' that is part still life and part abstraction. Dear Honorable Commissioners on the Cultural Heritage Commission of the City of Long Beach:

Regarding the hearing on Item # 21-003CH, on Tuesday, February 23, 2021, on two murals being proposed at 2800 E. 4th Street, in the Bluff Heights Historic District, I appreciate the detailed, well-reasoned Staff Report describing how this unique location could be an acceptable site for the drastic change to the external façade of a building (even if non-contributing) in an historic district. This kind of alteration would not otherwise be appropriate for, and should not be the source of a precedent in, the Bluff Heights Historic District nor in any of the other historic districts in the city.

I agree with and would request approval of the **Staff's two additional conditions**: First, in framing and significantly reducing the extent of the murals to minimize the building's coverage with the murals. Second, in working with the nearby residents and the Bluff Heights Neighborhood Association (BHNA) board, if they so choose, on an appropriate color scheme for the parts of the building that face the residential buildings in the Historic District.

Finally, while I hesitate at the idea of censoring art for decency, I agree with and respect the reasonable concern voiced by others that the **depiction of the female figure** may be perceived as exploitative and demeaning -- unless I am missing a connection to something or someone that the artist intended to convey. Art in the public realm should have oversight and be defensible, with consideration given to the current time, place and milieu in which we are living and to those whose likeness is represented in the artwork. As an aside, I cannot help to wonder if the murals' subject matter and color palette might in some way reflect or take from the historic nature of the Bluff Heights Historic District.



Dear Maryanne and the Cultural Heritage Commission,

I am a resident of the Bluff Park Historic District. I am writing to you regarding the proposed murals as a concerned resident.

I have looked at the 2 mural proposal for the building at 2800 E. 4th street - the intersection of Temple of 4th St. I am very familiar with this building having actually dined there many times prior when it was Cafe Neo.

To begin, I want to state that I support the arts and I do believe murals are a wonderful way to bring energy to areas. I think murals allow simple flat wall type buildings, alleys or parking lots to become more exciting. It seems a mural is typically better suited for facades that are larger, plain and more like the 2nd story northern face of the 2800 E. 4th Street building.



I feel the staff report touched upon one of my concerns and agree with its recommendations to make one of the elevations on the north side painted solid. I would go further to say perhaps there should probably only be one mural or more relief. I feel the two murals compete with each other and overwhelm the building. Personally, it seems the multiple large glass and door penerations don't really lend themself to a successful mural. I believe one mural would be a better focus.

I also agree with staff recommendation that the color of the plain paint should be consulted with neighbors - or perhaps even the Bluff Heights Neighborhood Association. Care should be made to make the residential side of the building more suited to the historic integrity of the historic district.

Lastly, I have heard concerns from residents of the exploitative nature of the woman depicted on the north side "green mural" and what that may represent. I share this concern. I realize artwork is very subjective, but perhaps as a recommendation, the young woman's middle finger could be lifted off her breasts or her holding the butterfly differently? I realize telling an artist what to paint is not ideal, but perhaps this can be remedied with something more simple in nature.

Thank you for your time. I hope this helps you and the CHC and it brings more insight for a decision. Sincerely,


