RECOMMENDATION:

Receive supporting documentation into the record, approve the Assessment Report, conclude the hearing, and declare the Ordinance approving the East Anaheim Street Parking and Business Improvement Area program and assessment for the period of July 1, 2010 through September 30, 2010, read the first time and laid over to the next regular meeting for final reading; and

Authorize the City Manager to execute an agreement with the East Anaheim Street Business Association for a three-month term beginning July 1, 2010. (Districts 3, 4)

DISCUSSION

The Parking and Business Improvement Area Law of 1989 of the California Streets and Highways Code allows for the creation of Business Improvement Areas, allowing business owners to voluntarily levy an assessment upon themselves to provide for improvements and activities.

Working in conjunction with the East Anaheim Street Business Association (EASBA), the businesses along Anaheim Street, between Junipero Avenue and Pacific Coast Highway, have petitioned the City for the creation of a business improvement district, i.e., the East Anaheim Street Parking and Business Improvement Area (EASPBIA). The new business improvement district shall be comprised of business licensees within the proposed boundaries, as described in the attached Ordinance.

Through the EASBA, the business community has already implemented programs to increase the attractiveness of the area, promote their unique products and services, reduce crime, and improve the economic vitality of area businesses.

Use of Funds

EASPBIA funds shall be used to administer marketing programs to promote the Anaheim Street shopping area and to fund projects, programs and activities that benefit the individual businesses within the boundaries of the EASPBIA. The EASBA, which is

the managing entity of the EASPBIA, shall be required to submit quarterly and annual financial and program reports.

The EASPBIA Initial Assessment Report and Proposed Service Plan (Assessment Report) details the boundaries of the EASBPIA, the amount and method of assessment for each business, and the improvements for which the assessment funds will be used. The assessment methodology will generate approximately \$132,710 in revenue during its first full program year. In order to form the EASPBIA in a timely manner, the initial term will be for the period July 1, 2010, through September 30, 2010. Estimated revenue for this initial term is \$33,178.

Adoption Process

State law further provides that the City Council shall hear and consider all protests against the assessment, program, boundaries of the area, and/or any benefit zone as proposed in the Assessment Report. The law allows the protests to be made orally or in written form. However, protests regarding the regularity or sufficiency of the proceedings shall be in writing. If written protests are received from area business owners representing 50 percent or more of the proposed assessments, the City Council shall not levy the assessment. If protests in such quantity are directed against a specific portion of the program, the City Council shall eliminate that portion.

A copy of Resolution No. 10-00031 declaring the intention to establish EASPBIA was mailed to all businesses in the district on March 29, 2010. A hearing notice and copy of the resolution has been published in local media as required.

Should the Assessment Report be approved, the City Council is requested to authorize the execution of an agreement with the EASBA for the use of assessment funds for the purposes outlined in the Assessment Report. The City Council shall also declare the Ordinance establishing the EASPBIA and setting the assessment for the period of July 1, 2010 through September 30, 2010, be read the first time and laid over to the next regular meeting for final reading (Attached).

This letter was reviewed by Assistant City Attorney Heather Mahood on March 2, 2010, Budget Management Officer Victoria Bell on March 31, 2010, and the City Treasurer's Office on February 25, 2010.

TIMING CONSIDERATIONS

City Council action is requested following the public hearing on April 20, 2010, to allow assessments to begin on July 1, 2010.

FISCAL IMPACT

It is expected the EASPBIA will generate \$33,178 for the balance of Fiscal Year 2010 (FY 10) through the proposed assessment and this will fully offset the proposed allocation for EASBA management costs of EASPBIA programs under contract with the City. Sufficient funds are currently appropriated for FY 10 activities in the Parking and Business Area Improvement Fund (SR 132) in the Department of Community Development (CD). Funding for the next fiscal year will be appropriated through the Fiscal Year (FY 11) budget process. There is no impact to the General Fund.

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH ESTABLISHING THE EAST
ANAHEIM STREET PARKING AND BUSINESS
IMPROVEMENT AREA (EASPBIA), FIXING THE
BOUNDARIES THEREOF, PROVIDING FOR THE LEVY OF
AN ADDITIONAL BUSINESS LICENSE TAX TO BE PAID BY
BUSINESSES IN SUCH AREA AND ESTABLISHING AN
ADVISORY BOARD

The City Council of the City of Long Beach ordains as follows:

Section 1. This Ordinance is made and enacted pursuant to the provisions of the Parking and Business Improvement Area Law of 1989 (Sections 36500, et. seq., of the Streets and Highways Code) (the "law").

- A. On March 23, 2010, the City Council of the City of Long
 Beach adopted Resolution No. ______ entitled, "A Resolution of
 Intention of the City Council of the City of Long Beach Declaring the
 Intention of the City Council to Establish the East Anaheim Street Parking
 And Business Improvement Area (EASPBIA) and Fixing the Time and
 Place of a Hearing Thereon and Giving Notice Thereof".
- B. Pursuant to said Resolution, a hearing concerning the formation of said area was held before the City Council of the City of Long Beach on April 20, 2010, at 5:00 p.m. in the Council Chambers of the City Hall of the City of Long Beach.
- C. All written and oral protests made or filed were duly heard, evidence for and against the proposed action was received, a full, fair and complete hearing was granted and held.

- D. All protests, both written and oral, made or filed were duly overruled and denied and the City Council determined that there was no majority protest within the meaning of Section 36525 of the law.
- Ε. That following such hearing, the City Council hereby finds that the businesses lying within the area herein created, in the opinion of the City Council, will be benefitted by the expenditures of funds raised by the assessment or charges proposed to be levied hereunder.
- Section 2. That pursuant to said law, the East Anaheim Street Parking And Business Improvement Area (EASPBIA) is hereby established in the City of Long Beach as herein set forth and that all businesses in the area established by this ordinance shall be subject to any amendments made hereafter to said law or to other applicable laws.

The boundaries of the EASPBIA are described in Section III of Section 3. the East Anaheim Street Parking and Business Improvement Area Initial Report and Proposed Service Plan ("Report"), attached as Exhibit "A."

Section 4. That the City Council hereby levies and imposes and orders the collection of, along with the City's usual annual business license fee, an additional assessment to be imposed upon persons occupying business premises in the proposed area described above, which shall be calculated pursuant to the Report, attached as Exhibit "A." Such levy shall begin on July 1, 2010, and its fiscal year shall be from October 1 through September 30.

That the proceeds of the additional business license tax shall Section 5. be spent for the purposes set forth in the Report, attached as Exhibit "A," within the boundaries of the EASPBIA. Funds remaining at the end of any EASPBIA term may be used in subsequent years in which EASBIA assessments are levied as long as they are used consistent with the requirements of this Section.

The City Council of the City of Long Beach shall have sole discretion as to how the revenue derived from said additional business license tax is to be used within the

I. DISTRICT OVERVIEW

Conceived by a coalition of business owners located along Anaheim Street east of Junipero, the East Anaheim Street Parking and Business Improvement Area (the "EASPBIA" or the "District") is a benefit assessment district proposed to provide a more attractive and vibrant business environment in the East Anaheim Street business area.

The goal of the district will be to promote and market the East Anaheim Street business area through events and advertising. The East Anaheim Street Business Alliance (EASBA), under contract with the City of Long Beach, will manage the District.

A. Location:

The East Anaheim Street Parking and Business Improvement Area is bounded by Junipero Avenue to the west, Pacific Coast Highway to the east, 11th Street to the south, 14th Street to the north. See map in Section II.

B. Services:

Marketing, promotions and cleanliness programs to improve the appearance and attractiveness of the business district.

C. Method of Assessment:

Special benefit assessment for marketing and promotion of businesses operating within the area. The estimated first full year revenue from business assessments is \$132,710. Estimated revenue for the initial partial year term of July 1 to September 30, 2010 is \$33,178.

Assessments are calculated as follows:

- <u>Type 1 Businesses</u>: Retail, recreation and entertainment, and unique businesses shall pay annual assessment fees of:
 - Base Fee: \$300 per year except that secondary licensees in these classes are exempt, and:
 - Employee Fee: \$15 per employee up to \$300 maximum.
- <u>Type 2 Businesses</u>: Service, vending, professional, wholesale, contractor, manufacturing and miscellaneous mobile businesses shall pay annual assessment fees of:
 - Base Fee: \$200 per year except that secondary licensees in these classes are exempt, and:
 - Employee Fee: \$15 per employee up to \$300 maximum

• <u>Type 3 Businesses</u>: Non-residential space rental businesses shall pay annual assessment fees of:

Base Fee:

\$120 per year

Employee Fee:

not applicable

Residential property rental, home-based and secondary licensees are exempt from the assessment.

D. Method of Collection


District assessments will be invoiced and due with annual City of Long Beach Business License renewal statements. The district fiscal year shall be the same as the City of Long Beach, October 1 through September 30 of each year. The initial term of the district shall be July 1 through September 30, 2010. Assessment revenue received will be segregated into a special fund for transfer to the EASBA.

E. Authority

The EASPBIA is a benefit assessment district formed under the authority of the State of California, Streets and Highways Code Part 6 (commencing with Section 36500) of Division 18; the Parking and Business Improvement Area Law of 1989 (the "District Law").

B. General Description

Based on the results of the 2008 Business Survey taken by business owners in the district area, the East Anaheim Street Business Alliance (EASBA) will work with member business on enhancing the identity and promoting the area for the benefit of all businesses. EASBA will also coordinate with the city to conduct street clean up activities, public safety programs and to deliver marketing and promotional services using funds received from EASPBIA assessments.

III. SERVICE PLAN AND BUDGET

A. District Needs and Purpose

The East Anaheim Street business area offers a unique neighborhood service, dining and shopping area. This area along Anaheim Street is a major east/west corridor and surrounded by quaint neighborhoods.

East Anaheim Street businesses have made strides in promoting the district in recent years. Working together as the East Anaheim Street Business Alliance, they have held regular meetings, gained the participation of the majority of the businesses in the area, involved the local residential neighborhood associations and have identified future events for the district such as:

- Create a unique identity for the area
- Sidewalk sales
- Holiday Open House events
- Street fairs
- Street Banners/Signs
- Regular street clean-ups
- Marketing and advertising Business alliance brochure and website

Formation of an assessment district will enable the EASBA to improve their ability to hold special events and increase funding for promotional activities while maintaining local control and accountability. Proposed additional services and programs include:

- Regular sidewalk and street cleaning
- Increased working with law enforcement and security
- East Anaheim Street gateway signs and light pole banners
- Increased marketing and promotion
- Improved overall sanitation services
- Additional street festivals, sidewalk sales and other public events

B. Service Plan

The EASPBIA Service Plan provides for funding for marketing and promoting and maintaining the cleanliness and attractiveness of the shopping area. Services to be provided are:

IV. ASSESSMENTS

A. Methodology

Improvements and activities identified in the Service Plan are designed to improve the appearance of pedestrian areas, improve safety and make the area more attractive to customers. All businesses in the district will benefit from these improvements and will be assessed according to the fee schedule below.

Special benefit assessment revenue for the initial term from July 1 through September 30, 2010 is estimated at \$33,178: Assessments are calculated as follows:

• <u>Type 1 Businesses</u>: Retail, recreation and entertainment, and unique businesses shall pay annual assessment fees of:

Base Fee:

\$300 per year except that secondary licensees

in these classes are exempt, and:

• Employee Fee: \$15 per employee up to \$300 maximum.

 <u>Type 2 Businesses</u>: Service, vending, professional, wholesale, contractor, manufacturing and miscellaneous mobile businesses shall pay annual assessment fees of:

Base Fee:

\$200 per year except that secondary licensees

in these classes are exempt, and:

• Employee Fee: \$15 per employee up to \$300 maximum

• <u>Type 3 Businesses</u>: Non-residential space rental businesses shall pay annual assessment fees of:

• Base Fee:

\$120 per year

• Employee Fee: not applicable

Residential property rental, home-based and secondary licensees are exempt from the assessment.

B. CPI Adjustments

The assessment may be increased each year to reflect the annual change in the Consumer Price Index for All Urban Consumers in Los Angeles-Riverside-Orange County. The annual increase shall not exceed three (3%) percent of the previous year's assessment. The annual Consumer Price Index variance will be calculated in March and applied in July of each year at the discretion of the Advisory Board. The District will have a fiscal year of October 1 through September 30.

C. Time and Manner for Collecting Assessments

Business operator assessments will be invoiced and due with annual City of Long Beach Business License renewal statements or other appropriate means as determined by City of Long Beach Financial Management. Assessment revenue received will be segregated into a special fund for transfer to the EASIA.

VII. DISTRICT GOVERNANCE

A. The East Anaheim Street Improvement Association


- 1. The East Anaheim Street Improvement Association shall manage the EASPBIA and shall exercise the powers of the Advisory Board set forth in the District Law including the following.
 - (a) The Advisory Board shall cause to be prepared a report for each fiscal year (October 1 through September 30) for which assessments are to be levied and collected to pay the costs of the improvements and activities described in the report. The report may propose changes, including, but not limited to, the boundaries of the parking and business improvement area or any benefit zones within the area, the basis and method of levying the assessments, and any changes in the classification of businesses, if a classification is used
 - (b) The report shall be filed with the clerk and shall refer to the parking and business improvement area by name, specify the fiscal year to which the report applies, and, with respect to that fiscal year, shall contain all of the following:
 - (1) Any proposed changes in the boundaries of the parking and business improvement area or in any benefit zones within the area.
 - (2) The improvements and activities to be provided for that fiscal year.
 - (3) An estimate of the cost of providing the improvements and the activities for that fiscal year.

- (4) The method and basis of levying the assessment in sufficient detail to allow each business owner to estimate the amount of the assessment to be levied against his or her business for that fiscal year.
- (5) The amount of any surplus or deficit revenues to be carried over from a previous fiscal year.
- (6) The amount of any contributions to be made from sources other than assessments levied pursuant to this part.
- (c) The City Council may approve the report as filed by the Advisory Board or may modify any particular contained in the report and approve it as modified. The City Council shall not approve a change in the basis and method of levying assessments that would impair an authorized or executed contract to be paid from the revenues derived from the levy of assessments.
- 2. The East Anaheim Street Business Alliance board will serve and the EASPBIA Advisory Board and shall be appointed by the Mayor and confirmed by the City Council as required by District Law.
- 3. The EASPBIA Advisory Board shall comply with the Brown Act when discussing or acting on matters within the subject matter of the district (e.g. annual report assessment methodology, boundaries, budget and Service Plan).

B. Disestablishment

According to State law, any district where there is no outstanding indebtedness may be disestablished by resolution of the City Council. This may occur if the City Council finds that funds have been improperly used or if the assessees request disestablishment.

There will be a thirty-day window every year beginning on the one-year anniversary of the establishment of the District, in which business owners may petition to disestablish the District. If the assessees who pay 50% or more of the total assessments levied submit a written petition to disestablish the District, the City Council will do so.
