Correspondence has been received from Reginald Harrison, Director of the Department of Disaster Preparedness and Emergency Communications, requesting Civil Service Commission approval to reappoint Rachel Richard to her former classification of Public Safety Dispatcher II. Staff has reviewed the request and recommends that the Commission approve the reappointment of resigned employee, Ms. Rachel Richard, in accordance with Article V, Section 45 of the Civil Service Rules and Regulations.

Facts for Consideration:

- Ms. Rachel Richard was hired as a full-time Public Safety Dispatcher I on May 16, 2015 and passed probation to receive permanent status in the classification on June 20, 2016.
- Ms. Richard resigned from her classified position in good standing on October 17, 2020.
- On March 16, 2021, Ms. Richard sent correspondence to Communications Center Officer, Dan Cunningham, requesting to be considered for reinstatement as a Public Safety Dispatcher II with the Department of Disaster Preparedness and Emergency Communications.
- The Department supports the reappointment of Ms. Richard to the classification of Public Safety Dispatcher II.
- Ms. Richard has been advised by the department on the terms and conditions of her reappointment regarding benefits, salary, department status, and working conditions.
- The Civil Service Department received requisition DC20-008 on June 23, 2020 for 25 vacancies in which 2 vacancies have been filled as of March 17, 2021.
- Ms. Richard will fill a current vacancy in the Public Safety Dispatcher I-IV classification, leaving 22 vacancies remaining to be filled. The Department has stated that there is an immediate need to fill vacancies due to staffing concerns at this time.

- Current eligible lists exist for the Public Safety Dispatcher I-IV classification and the department is actively interviewing and sending candidates through background investigations. However, training and probation require one year to complete. Ms. Richard is adequately trained and has over five years of recent experience as a Public Safety Dispatcher with the City of Long Beach.
- Civil Service Staff has informed Ms. Richard of the terms and conditions of the reappointment including the fact that she must complete a new probationary period.
- The Department of Disaster Preparedness and Emergency Communications and Ms. Richard have been informed that this request is on today's agenda. A department representative will be present to answer any inquiries from the Civil Service Commission.
