SIXTH AMENDMENT TO AGREEMENT NO. 33913

THIS SIXTH AMENDMENT TO AGREEMENT NO. 33913 is made and entered, in duplicate, as of February 12, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 9, 2020, by and between MARY MCGRATH ARCHITECTS, a California corporation ("Consultant"), with a place of business at 1212 Broadway, Suite 401, Oakland, California 94612, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33913 (the "Agreement") whereby Consultant agreed to provide as-needed architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 19, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to July 19, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$600,000 to the Agreement for a total not to exceed amount of \$1,000,000; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to July 19, 2020; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to extend the term to July 19, 2021; and

WHEREAS, the Parties desire to add \$869,816.19 for a total not to exceed amount of \$1,869,816.19;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this

reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Eight Hundred Sixty-Nine Thousand Eight Hundred Sixteen Dollars and Nineteen Cents (\$1,869,816.19), at the rates or charges shown in Exhibit "B"."

 Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33913 are ratified and confirmed and shall remain in full force and effect.
