CONSOLIDATED PLAN

Five Year Plan (2018 – 2023):

- Pre-application requisite for federal funds explaining how the City will provide services to low and moderate income individuals and families residing within Long Beach.
- The current FY 2017–2022 Consolidated Plan was approved by LBCIC, City Council and HUD in 2017 and has been in effect since October 1, 2017 and will remain in effect until September 30, 2022.



Action Plan

- The Action Plan provides a concise summary of the actions, activities, and the specific federal resources that will be used to address the priority needs and specific goals identified in the Consolidated Plan.
- The FY 22 Action Plan is the fifth and last of five Action Plans under the 2017-2022 Consolidated Plan.




CAPER



FY 2022 AP DEVELOPMENT STRATEGIES

- Collect public input and conduct public workshops;
- 2. Continue to address the priority needs and goals described in the current Five-Year Con Plan;
- 3. Examine entitlement trends (see chart); and
- 4. Analyze available resources for FY 22 Action Plan, including estimated program income and AP amendments for carryover funds.





FEDERAL GRANT UPDATE

- 1. The Congressional Funding level for CDBG increased from \$3.39 billion in FY 20 to \$3.44 billion in FY 21, a **1.5% increase.**
 - > FY 21 City of Long Beach Allocation: \$5,806,569 (6% decrease)
- 2. The Congressional Funding level for HOME increased from \$1.35 billion in FY 20 to \$1.35 billion in FY 21, an **0% change.**
 - > FY 21 City of Long Beach Allocation: \$2,825,606 (3% decrease)
- 3. The Congressional Funding level for ESG increased from \$290 million in FY 20 to \$290 million in FY 21, a **0% change.**
 - > FY 21 City of Long Beach Allocation: \$524,632 (2% decrease)
