FIRST AMENDMENT TO AGREEMENT NO. 35268

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with light and medium vehicle body repair ("Project"); and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35268 (the "Agreement") whereby Consultant agreed to provide these services as described in Request for Proposals number FS19-042; and

WHEREAS, the Parties desire to increase funds and renew the contract for an additional one-year period and;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Six Hundred Thousand Dollars (\$600,000) annually, at the rates or charges shown in Exhibit "B"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:

"The term of this Agreement shall commence at midnight on July 1, 2019, and shall terminate at 11:59 p.m. on June 30, 2022, with the option to renew for two (2) additional one (1) year periods, unless sooner terminated as provided in this Agreement.
