SECOND AMENDMENT TO AGREEMENT NO. 35241

THIS SECOND AMENDMENT TO AGREEMENT NO. 35241 is made and entered, in duplicate, as of May 4, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 18, 2020, by and between PEDAL MOVEMENT LLC, a California limited liability company ("Consultant" or "Contractor"), with a place of business at 223 E. First Street, Long Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35241 (the "Agreement") whereby Consultant agreed to perform ongoing operation and maintenance of the Long Beach Bike Share Program; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to December 31, 2020; and

WHEREAS, the Parties desire to add \$615,000 to the Agreement and amend the Scope of Work;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, for the term January 1, 2019 to December 31, 2019, a total not to exceed amount of One Million Four Hundred Ten Thousand Six Hundred Forty-Two Dollars (\$1,410,642); and for the term January 1, 2020 to December 31, 2020, a total not to exceed amount of Two Million One Hundred Seventeen Thousand Eight Hundred Ninety-Two Dollars (\$2,117,892); for a combined total not to exceed contract amount of Three Million Five Hundred Twenty-Eight Thousand Five Hundred Thirty-Four Dollars (\$3,528,534), at the rates or charges shown in Exhibit "B"."

SCOPE OF WORK FOR 2ND AMMENDMENT TO CONTRACT 35241

Re: Contract No. 35241

Pedal Movement will refurbish 514 SoBi bicycles purchased by the City of Long Beach in March of 2020 to prepare for the upcoming growth of the BikeShare program, the incorporation of electric bikes, and additional staff and resources necessary for Pedal Movement to properly operate and maintain the nearly doubled in size bicycle fleet. The city agrees to pay Pedal Movement \$368,600 for the Vendors work to make the 514 SoBi bicycles fully operational and available for service after the refurbishment process is completed.
