WHEREAS, the subject interim regulations (moratorium) will provide the City and City staff, together with input from the public, an opportunity to determine how the current Zoning and/or building regulations can best be amended to eliminate, to the extent reasonably feasible, the conflict between the current regulations and the newly adopted LUE and UDE; and

CA 90802-4664 WHEREAS, the City's planning staff and the Planning Commission will undertake the necessary study of residential construction along transportation corridors described above and will prepare an implementation plan and recommended action for consideration by the City Council in due course; and

WHEREAS, the goal of any new residential construction along the above described transportation corridors is to develop comprehensive regulations which recognize and balance the various interests related to residential construction in commercial zones and transportation corridors in a manner tailored to the City's unique needs and community vision, and which are supportive of establishing environments that are more walkable and pedestrian friendly environments and which provide surrounding residents access to neighborhood-serving commercial uses and other necessary amenities, and which reflect the land use and zoning policy choices of the City as reflected in the General Plan; and

WHEREAS, until the policy study as described above is undertaken and
completed by City Staff and the Planning Commission and any new regulations are
adopted by the City Council, there is a significant risk that some individuals or entities
may make investments in new residential construction in commercial corridor areas
described above that would soon thereafter be illegal, nonconforming, or subject to an
amortization program; and

WHEREAS, on May 18, 2021, the City Council adopted after a public hearing and public input, a minute order pursuant to an agenda request which initiated a 2 moratorium relating to the issuance of building or construction permits, or other 3 entitlements for new stand-alone residential construction in areas that are designated by 4 the 2019 General Plan Land Use Element Update as the Neighborhood-Serving 5 Corridors or Centers PlaceType on the Willow Street and Santa Fe Avenue corridors in 6 the City, and declared the urgency thereof. 7

NOW, THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Purpose and Findings. At the direction of the City Council, the 10 Development Services Department and the Planning Commission will undertake a policy 11 study of potential amendments to the Zoning Regulations and Building Codes of the City 12 of Long Beach ("City") regulating, limiting or prohibiting new residential construction along 13 commercial and transportation corridors in in areas that are designated by the 2019 14 General Plan Land Use Element Update as the Neighborhood-Serving Corridors or 15 Centers PlaceType on Willow Street, west of the I-710 freeway to the City terminus; and 16 Santa Fe Avenue, between Pacific Coast Highway on the south and Wardlow Road on 17 the north, in the City of Long Beach. The City Council specifically finds that the existing 18 regulations contained in the City's Zoning and/or Building regulations may be in conflict 19 with the Zoning and Building regulations that are or will be studied by the Development 20 Services Department and the Planning Commission pursuant to the City Council's 21 direction. 22

Section 2. Estimated Time for Completion of Study. It is estimated that 23 the study or studies undertaken in connection with the adoption of this interim ordinance 24 may take the Development Services Department and the Planning Commission 25 approximately twelve (12) months to complete. 26

Section 3. Prohibition.

Notwithstanding any provision of the Long Beach Municipal Code to the

contrary, for a period of twelve (12) months from the effective date of this Ordinance, 1 which would be June 15, 2022, or until a permanent ordinance becomes effective. 2 whichever occurs first: 3

Α. No application shall be accepted for a building or construction permit, or other entitlement for new residential stand-alone construction on the transportation corridors in West Long Beach on Willow Street, west of the I-710 freeway to the City 6 7 terminus; and Santa Fe Avenue, between Pacific Coast Highway on the south and Wardlow Road on the north, in the City of Long Beach. 8

Β. No building or construction permit, or other entitlement for new 9 residential stand-alone construction on the transportation corridors on in West Long Beach 10 on Willow Street, west of the I-710 freeway to the City terminus; and Santa Fe Avenue, between Pacific Coast Highway on the south and Wardlow Road on the north, in the City, 12 shall be issued. 13

Section 4. Exceptions.

Α. The prohibitions specified in Section 3 of this Ordinance shall not 15 apply to residential stand-alone construction along transportation corridors in West Long 16 Beach on Willow Street, west of the I-710 freeway to the City terminus; and Santa Fe 17 Avenue, between Pacific Coast Highway on the south and Wardlow Road on the north, for 18 which a permit application is required as follows: 19

1. In order to comply with an order issued by the Department of 20 Development Services to repair, remove, demolish or maintain any unsafe or a 21 substandard condition; or 22

2. In order to replace or repair damage as a result of fire, 23 earthquake, or other natural disaster, provided that the replacement or repair is not 24 prohibited by any other provision of the Long Beach Municipal Code. 25

Β. The prohibitions specified in Section 3 of this Ordinance shall not 26 apply to any building or construction permit or other entitlement issued for new residential 27 stand-alone construction along the transportation corridors on Willow Street, west of the 28

I-710 freeway to the City terminus; and Santa Fe Avenue, between Pacific Coast Highway
 on the south and Wardlow Road on the north, prior to 5:00 p.m. on May 18, 2021.

C. The prohibitions specified in Section 3 of this Ordinance shall not apply to the routine maintenance or repair of existing residential stand-alone construction on the transportation corridors on Willow Street, west of the I-710 freeway to the City terminus; and Santa Fe Avenue, between Pacific Coast Highway on the south and Wardlow Road on the north, provided that the residential construction is not enlarged in any manner. During the period of this interim ordinance no residential construction along transportation corridors on Willow Street, west of the I-710 freeway to the City terminus; and Santa Fe Avenue, between Pacific Coast Highway on the south and Wardlow Road on the north, shall be removed and replaced for the purposes of modernization, except pursuant to an order issued by the Department of Development Services.

Section 5. Severability. If any provision of this Ordinance is found to be unconstitutional or otherwise invalid by any court of competent jurisdiction, that invalidity shall not affect the remaining provisions of this Ordinance which can be implemented without the invalid provision, and, to this end, the provisions of this Ordinance are declared to be severable.

Section 6. Applicability of the Zoning Code. The regulations of this
 Ordinance are in addition to those set forth in the planning and zoning provisions of
 Chapter 21 of the Long Beach Municipal Code, and any other ordinances adopted by the
 City Council, and do not contain any rights not otherwise granted under the provisions
 and procedures contained in Chapter 21 or any other ordinances.

Section 7. Urgency Clause. The City Council finds and declares that this
 ordinance is required for the immediate preservation of the public peace, health and
 safety for the following reasons. This ordinance is necessary to prevent irreversible
 development from occurring pending adoption of a permanent ordinance or regulations
 by preventing permits for the construction of new stand-alone residential construction on
 Willow Street, west of the I-710 freeway to the City terminus; and Santa Fe Avenue,

between Pacific Coast Highway on the south and Wardlow Road on the north, which
would possibly undermine the recommendations for updating the zoning and/or building
regulations regarding new residential stand-alone construction along the commercial and
transportation corridors described above. Therefore, this Ordinance shall become
effective upon adoption pursuant to Long Beach City Charter Sections 211 and 212, and
Chapter 21.50 of the Long Beach Municipal Code.

Section 8. The City Council finds and determines that the proposed
interim ordinance is not in conflict with the various provisions of the California Coastal Act
because, among other things, the proposed interim ordinance does not in any way affect
access to or the enjoyment of coastal related activities and the areas in question are not
in the City's coastal zone.

Section 9. Declaration of Urgency. This ordinance is an emergency 12 measure, and it is urgently required for the reason that, pending completion of the 13 necessary planning policy study, and a determination relative to the potential need to 14 amend the Zoning or Building regulations of the City, it is necessary to temporarily 15 prohibit the issuance of construction or building permits or other entitlements related to 16 new residential stand-alone construction on Willow Street, west of the I-710 freeway to 17 the City terminus; and Santa Fe Avenue, between Pacific Coast Highway on the south 18 and Wardlow Road on the north, in order to avoid the adverse impacts that might arise 19 with the pending revisions to the Zoning or Building regulations of the City being 20 considered during the interim period. 21

Section 10. This ordinance is an emergency ordinance duly adopted by the City Council on June 15, 2021, by a vote of at least five (5) of its members and shall take effect immediately. The City Clerk shall certify to a separate roll call and vote on the question of the emergency of this ordinance and to its passage by the vote of five members of the City Council of the City of Long Beach, and cause the same to be posted in three conspicuous places in the City of Long Beach.

Section 11. This ordinance shall also be adopted by the City Council as a

1 regular ordinance, to the end that in the event of any defect or invalidity in connection



Section 12. The City Clerk shall certify to the passage of this ordinance by
