RECOMMENDATION:

Recommend to the Government, Personnel and Election Oversight Committee to rename the Sports Complex at Chittick field "Dee Andrews Sports Complex at Chittick Field." (District 6)

DISCUSSION

On November 17, 2020, Eighth District Councilmember, Al Austin requested that the Mayor and the members of the City Council refer to the Parks and Recreation Commission a request to recommend that the sports complex at Chittick Field be named for Dee Andrews (Attachment A). Chittick Field is a City-owned park located at 1900 Walnut Avenue (Attachment B).

This item was presented to the Parks and Recreation Commission (Commission) at the January 21, 2021 meeting. The recommendation was amended to approve with the caveat that Council District Eight and Council District Six should seek additional public input that would include the proposed signage and location and keep the name "Chittick" pre-eminent and return to Commission for further consideration. Additional public support was received from individuals and community organizations. The item was brought back to the Commission at the May 20, 2021 meeting for further consideration and was passed by the Commission with a vote of six commissioners for and one against the naming.

The City's Policy and Process for Naming of City-owned Land, Buildings, and Facilities Administrative Regulation (AR 8–7) provides the policy to guide the consideration of a naming request:

- The name should incorporate Long Beach whenever important for civic recognition or identification;
- A name in honor of a recognized geographic area, a topographic feature or a historically significant event may be appropriate;
- A name in honor of persons or families who have donated the land or a substantial portion of the improvement costs may be appropriate when applicable;
- A name in honor of a person or persons who have served the nation, the State of California, and/or the City of Long Beach in an exceptional or distinguished manner may be appropriate if warranted by service of major significance;
- A name in honor of a living person, or of a deceased person within one year of their death, is not appropriate unless the significance of that person's contribution is worthy of an exception to the policy;

- A name in honor of a person is not appropriate when a name in honor of another person has been given to the same site, building or facility in the past;
- A name in honor of a person is not appropriate if that person been overly recognized in the past, and;
- A name may be selected through a competition or a contest.

In accordance with AR 8-7, Councilmember Austin's naming request is referred to the Parks and Recreation Commission. The naming request includes the justification included in Attachment A since the individual included in the proposed naming request is a living person and requires an exception to policy. The Parks and Recreation Commission (Commission) recommendation will be transmitted to the Housing and Neighborhoods Committee and then back to the City Council for final confirmation, consistent with AR8-7.

FISCAL IMPACT

The total cost for fabrication and installation of a standard park flag sign is estimated to be \$2,300. If a different type of signage is desired, an estimate would be obtained and presented to the Council Office for consideration. Implementation of this recommendation is anticipated to result in a moderate impact to staff hours beyond the normal budgeted scope of duties and a moderate impact to Parks, Recreation and Marine Department budget and City Council priorities.

Subject: Naming of Sports Complex at Chittick Field for Dee Andrews

RECOMMENDED ACTION:

Refer to the Parks and Recreation Commission and the Housing and Neighborhood Committee for consideration of naming the athletic complex at Chittick Field for Vice Mayor Dee Andrews.

BACKGROUND:

Vice Mayor Dee Andrews is completing his service on the City Council after more than 13 years representing the Sixth District. First elected in 2007, Andrews has often been referred to as the "Son of the Sixth" for his 60-year involvement with the Central Long Beach district. Andrews has served as Vice Mayor since 2018.

One of Vice Mayor Andrews' signature accomplishments on the City Council was securing the funding and overseeing the completion of a remodeled Chittick Field Sports Complex.

The new \$9.9-million, 19-acre sports complex was opened in 2014, featuring a new football field, three soccer fields, and a 400-meter all-weather track. The project also included new parking, lighting, restrooms, a bike path, and a new pump station and stormwater accommodations.

Andrews' connection with this site dates back far longer, as he played at what was then known as Hamilton Bowl in the 1950s, on his way to becoming a Poly High School athletics legend.

Given Dee Andrews' long-time connection with athletics at the Chittick Field site, and his involvement in the transformation of the athletic fields, it seems appropriate as recognition for his contributions to the Sixth District and Chittick Field to name the athletic fields at the site in his honor.

FISCAL IMPACT: No fiscal impact was able to be conducted for the referral to the appropriate commission and committee, but any fiscal impact can come back to the City Council as part of a final recommendation.

Dear Mayor Garcia and City Council,

I am writing in support of the Athletic Complex at Chittick Field to be named after Long Beach Vice Mayor Dee Andrews. His service to the City of Long Beach and thousands of graduates of the Long Beach Unified School District are reasons enough to honor Mr. Andrews this way. But I want to share a story from long before Mr. Andrews began his life of service.

One of the last persons my Dad, William B. Seal, wanted to see before his passing was Dee Andrews. I asked my Dad why it was so important to him and what did he want to say to him. Dad told me that he was a Summer Camp Counselor at Camp Tahquitz each summer before and a few years after I was born. He told me that each summer he made sure to put Mr. Andrews under his care. Here is what he told me about Dee Andrews from his hospital bed on video:

"When Dee was a young man, he began coming to Camp Tahquitz during the summer. There was something very unique about Dee. He didn't come to Camp with much more than his personality, his inquisitiveness and his contagious joy. He was very bright. He was the brightest Scout I have ever had. Whether it was canoeing, swimming, night hikes, Campfire Shows, Camp Service Projects, Scouting and learning about nature, Dee was ahead of all of the other Scouts. I spent many hours with Dee each summer encouraging him to go to college and become a teacher and become a Camp Tahquitz Counselor. During the school year, I was able to check in on him through the LBUSD phone tree for teachers."

"I want to see him to tell him I'm proud of him, everything he has accomplished and everything he has overcome. Judy, endorse him for me. Let him know I enjoyed him whenever I saw him. He watched out for the safety of other Scouts and became highly respected for his knowledge of nature and survival techniques. Dee had a lot of energy. He learned critically important safety measures and taught them to other Scouts. That smile. That smile. Dee's smile is everything." My Dad smiled the entire time he spoke of Dee. He continued.

"Dee had much to overcome in his life including living in a Long Beach that was by and large unpleasantly segregated. He did not want to be fenced into anything in his life and I respected that. Without that strength, he would not be where he is today. Nothing fell into his lap, nothing. He managed somehow to remain positive when society was not working with or for him. You do not fully understand how far Dee has come in his life, but I do. I witnessed him growing up. Yes, he was a character and still is, but he has character and character is as important to society as knowing survival skills in nature. There were no shortcuts in Dee's life. He persevered through it all, most especially the Civil Rights movements of the 1960's and 1990's. Judy, tell him I love him and that I asked for him."

Considering all that my Dad told me about Dee that day, just 48 hours before he passed away, and considering all that I witnessed of Dee in my own life, naming the Athletic Complex at Chittick Field after Vice Mayor Dee Andrews is all too fitting. It would make my Dad very happy, I know this to be true. Camping and swimming, hiking and fishing, taking care of others and being prepared to step in to help others under any circumstance was my Dad's recipe for being of service to others and staying positive. I know because he prepared me the same way. An Athletic Complex named after Dee Andrews does not just validate the person Dee is. It validates who my Dad was. It lifts my spirits greatly and I hope I am invited to the ceremony.

This week it was brought to my attention that the City of L.B. was attempting to rename Chittick field, the field named after my late father, Cline Chittick . This news struck me and the Chittick family very hard. It was like losing my father all over again. This is why my brother (Brian Chittick) and I are writing you, to let you know who my father was, and why the field is named after him.

As far back in my memory of my father Cline William Chittick, being a graduate of Poly High School, and after returning from the war, he was involved in many things around the community, working for the L.B. school district for 38 years, he was a Scout Master and Scout leader for many years. During my elementary school years, Dad donated his time for my school Clara Barton (where my mother was P.T.A. President.) for the school carnivals, building booths and holding newspaper drives. Whenever he was needed he was there to help.

As for K.B.A.(Kid Baseball Association) he was involved many years before my brother and I were born and adopted as babies in the late 50's . He had joined in the beginning day of K.B.A. with our uncle, Chuck Stevens (A Long Beach Allstar & Pro Baseball player) and others who had started K.B.A. Dad would do pretty much everything and anything for K.B.A. our home was like a distribution center for uniforms and trophies for coaches and players during baseball season. I remember driving with my father from one end of town to the other picking up any kid who didn't have a ride to their respective baseball game. He would then return them home at the end of the evening. He would do this every night there were games throughout the city. Every year K.B.A. held the baseball jamboree. Dad was there making sure everything ran as smoothly as humanly possible, he was President of K.B.A.

After my dads passing it was Mayor Kell who proposed the field be named in my fathers honor.

In 1978 my dad was honored with the Walt Marshall Award. This award was given in recognition of his demonstration of consistent promotion of youth athletic programs. Any change to the name of Chittick Field would be a disservice and insult to the years of effort my father gave to the thousands of kids in the City of Long Beach.

Dear Council Members,

My name is Brian Chittick. I am Cline W. Chittick's son. My sister, Karen Chittick Angel and I recently found out that the current Long Beach City Council was trying to change the name of Chittick Field. This proposed name change involves ignoring and breaking at least two rules and regulations that have been enforce for over 100 years. This is an insult to my Father and family. Ernie Kell, the City Council and dozens of community leaders wanted to show their respect and appreciation by giving his name to a place where thousands of young people played. Chittick Field was dedicated shortly after my Father's death.

After viewing a closed Long Beach City Council meeting, it was easy for this city council to break the rules and regulations pertaining to naming city owned properties. From their comments, it was clear that not one of them knew or cared anything about Cline Chittick.

This letter is to give you a brief look into Cline Chittick's life and the impact he had in Long Beach. Any more than a brief look would contain dozens of volumes. I have listed just a few periods in my Father's life that helped shape his character and beliefs.

My Father grew up not knowing who his Father was living with his Pastor grandmother. His single mother could not afford to take care of him and his sister, so she left the two of them with her mother. They were very poor. My Father was an extremely smart and talented boy and young man. He taught himself to play the harmonica and guitar. He also had a great singing voice. In 1925, at age 12, he won a talent contest, sponsored by FOX West Coast, the Elks Club and a few radio stations. He was awarded the title of Mouth Organ Sousa of Long Beach. Hal Nichols, owner of KFOX Radio on Anaheim Street saw the contest and hired my Dad. Every day after school he would be on the radio as Freckles on a program called Butter Cream School House. His small income was a blessing for his grandmother and sister. He was the major income supporter for his family. At Poly High School, he was a gifted athlete. In 1928, he participated in the Junior Olympics in Los Angeles. After graduation from Poly, Dad volunteered to help with the track and football teams at Poly and Wilson High. At this time, he joined several service organizations including the 20/30 Club, YMCA and the Masons.

During the earthquake of 1933, my Father was in the basement of the Breakers Hotel in downtown Long Beach. In his rush to get home to check on his grandmother and sister, he helped rescue several people that were trapped in a collapsed building. He was recognized by the City and the Long Beach Press Telegram. The article stated local radio star, C. Chittick, helped save elderly couple from collapsed building.

Through 1934, Dad continued to work at KGER, KFOX, KFI and KHJ as well as helping the kids at Franklin, Wilson and Poly High Schools. In late 1935, he went on tour with Harry Fletcher and The Purple Sage Riders of the RKO Circuit. He toured the country ending in New York City. It was at this time that he missed Long Beach. Dad was offered a job at Long Beach Unified School District. He was hired to start and run the new Audio/Visual Department. He was with LBUSD for 38 years, excluding the WWII years.

During WWII, my Father was a highly decorated combat photographer. He was involved in three invasions and seven major engagements. These included the Normandy Invasion D-Day, June 6, 1944, Bloody Omaha Beach and the Battle of the Bulge. He was in the European Theater for almost four years. Very few of his original Division returned. He was awarded one Silver Star with two oak leaf clusters, three Bronze Stars and The French Croix de Guerre.

After the war, my Father went back to work for LBUSD. He continued to build and improve the Audio/Visual Department. It was at this time that Dad became involved with Kid Baseball Association of Long Beach. KBA was founded by my uncle, Chuck Stevens, Vern Stephans, Charlie Brown and Bob Lemon. The Association was formed to give the children of Long Beach, especially kids in the lower income areas, an organized, positive avenue to sports and life. In those days, organized youth sports did not exist in Long Beach, especially in the central, west side and north Long Beach areas. KBA offered good, clean, organized youth baseball with dedicated coaches that really cared about the kids.

My Father started as a coach, then Commissioner and then President. He always continued the original values and goals of the Association. Every evening, my Dad would travel around the city visiting team after team. He wanted to make sure that all the teams had the equipment they needed or wanted. All the coaches, players and parents knew who Cline Chittick was and knew that he always had their children's best interest and future as his number one priority.

My Father accomplished more in his life than most people would ever dream of. His accomplishments were not judged by monetary gains but by positive life influence. He knew what it is like to have nothing and what it was like to live each day as if it were your last. How good it felt to see a child grow up and live a positive, happy, healthy life. He touched the lives of thousands of children. Thirty-eight years after his passing, children of those children are passing on those lessons that he taught all of us.

As I said at the start of this letter, this proposed name change involves ignoring and breaking at least two rules and regulations that have been enforce for over 100 years. These rules and regulations were put in for exactly the reason this letter is being written. Those who wrote the Administrative Rules and Regulations were wise enough to know there would be future generations or councils that would want to ignore, break or change the accomplishments and achievements of past generations. These two regulations were put in exactly to stop this issue.

DISCUSSION

On November 17, 2020, Eighth District Councilmember, Al Austin requested that the Mayor and the members of the City Council refer to the Parks and Recreation Commission a request to recommend that the sports complex at Chittick Field be named for Dee Andrews (Attachment A). Chittick Field is a City-owned park located at 1900 Walnut Avenue (Attachment B).

This item was presented to the Parks and Recreation Commission (Commission) at the January 21, 2021 meeting. The recommendation was amended to approve with the caveat that Council District Eight and Council District Six should seek additional public input that would include the proposed signage and location and keep the name "Chittick" pre-eminent and return to Commission for further consideration.

The City's Policy and Process for Naming of City-owned Land, Buildings, and Facilities Administrative Regulation (AR 8–7) provides the policy to guide the consideration of a naming request:

- The name should incorporate Long Beach whenever important for civic recognition or identification;
- A name in honor of a recognized geographic area, a topographic feature or a historically significant event may be appropriate;
- A name in honor of persons or families who have donated the land or a substantial portion of the improvement costs may be appropriate when applicable;
- A name in honor of a person or persons who have served the nation, the State of California, and/or the City of Long Beach in an exceptional or distinguished manner may be appropriate if warranted by service of major significance;
- A name in honor of a living person, or of a deceased person within one year of their death, is not appropriate unless the significance of that person's contribution is worthy of an exception to the policy;
- A name in honor of a person is not appropriate when a name in honor of another person has been given to the same site, building or facility in the past;

- A name in honor of a person is not appropriate if that person been overly recognized in the past, and;
- A name may be selected through a competition or a contest.

In accordance with AR 8-7, Councilmember Austin's naming request is referred to the Parks and Recreation Commission. The naming request includes the justification included in Attachment A since the individual included in the proposed naming request is a living person and requires an exception to policy. The Parks and Recreation Commission (Commission) recommendation will be transmitted to the Housing and Neighborhoods Committee and then back to the City Council for final confirmation, consistent with AR8-7.

FISCAL IMPACT

The total cost for fabrication and installation of a standard park flag sign is estimated to be \$2,300. If a different type of signage is desired, an estimate would be obtained and presented to the Council Office for consideration. Implementation of this recommendation is anticipated to result in a moderate impact to staff hours beyond the normal budgeted scope of duties and a moderate impact to Parks, Recreation and Marine Department budget and City Council priorities.
