## FIRST AMENDMENT TO AGREEMENT NO. 35373

## 

THIS FIRST AMENDMENT TO AGREEMENT NO. 35373 is made and entered, in duplicate, as of June 11, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 21, 2019, by and between R.S. CAMPBELL CONSULTING, INC., a California corporation ("Consultant"), with a place of business at 1161 Marine View Dr., Vista, CA 92081, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with professional services supporting the deployment of the proprietary software system Envision Connect (EC) ("Project"); and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35373 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire execute a First Amendment to increase the amount of the contract to One Hundred Forty Thousand Dollars (\$140,000) and extend the term for one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.

"Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Hundred Forty Thousand Dollars (\$140,000), at the rates or charges shown in Exhibit "B"."

2. Section 2. of the Agreement is hereby amended to read as follows.

"The term of this Agreement shall commence at midnight on September 1, 2019, and shall terminate at 11:59 p.m. on August 31, 2022, unless sooner terminated as

provided in this Agreement, or unless the services or the Project is completed sooner. The City shall have the option to extend the term for two (2) additional one-year periods, at the discretion of the City Manager."

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35373 are ratified and confirmed and shall remain in full force and effect.
