FIRST AMENDMENT TO AGREEMENT NO. 35724

THIS FIRST AMENDMENT TO AGREEMENT NO. 35724 is made and entered, in duplicate, as of June 22, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 21, 2019, by and between THE CHILDREN'S CLINIC 'SERVING CHILDREN AND THEIR FAMILIES', DBA TCC FAMILY HEALTH, a California nonprofit corporation ("Contractor"), with a place of business at 701 E. 28th Street, Suite 200, Long Beach, Ca 90806 and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with Hepatitis C Prevention, Testing, and Treatment which includes, but is not limited to, testing navigation, linkage to care, care coordination, and treatment, among vulnerable and undeserved clients at high risk for Hepatitis C, with an emphasis on priority settings ("Project"); and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35724 (the "Agreement") whereby Contractor agreed to provide these services; and

WHEREAS, the Parties desire to enter into a First Amendment to increase the contract amount to One Hundred Eighty-Six Thousand Five Hundred One Dollars (\$186,501) and extend the term for one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.

"Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Hundred Eighty-Six Thousand Five Hundred One Dollars (\$186,501) annually, at the rates or charges shown in Exhibit "B"."

2. Section 2. of the Agreement is hereby amended to read as follows.

"The term of this Agreement shall commence at midnight on July 1, 2020, and shall terminate at 11:59 p.m. on June 30, 2022, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The City shall have the option to extend the term for two (2) additional one-year periods, at the discretion of the City Manager."

- 3. Exhibit "B" is hereby amended and replaced with Exhibit "B-1", attached hereto and incorporated herein.
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35724 are ratified and confirmed and shall remain in full force and effect.
