

FOURTH AMENDMENT TO AGREEMENT NO. 34358

THIS FOURTH AMENDMENT TO AGREEMENT NO. 34358 is made and entered, in duplicate, as of June 9, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 14, 2020, by and between HNTB CORPORATION, a Delaware corporation ("Consultant"), with a place of business at 200 E. Sandpointe Ave., Suite 200, Santa Ana, California 92707, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34358 ("Agreement") whereby Consultant agreed to provide the specialized services as described in Request for Qualifications AP16-105; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$3,350,000 to the Agreement and update the scope of work and fee schedule; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to update the rate schedule; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to August 28, 2021 and increase the Agreement amount; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and attach an updated rate schedule;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 29, 2016, and shall terminate at 11:59 p.m. on August 28, 2022, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. The Rates contained in Exhibit "B-3" to the Third Amendment is hereby amended and replaced by Exhibit "B-4", attached hereto and incorporated herein.
