Adopt Specifications WD-20-21 for the Large Potable Water Valve Replacement Project – Redondo Avenue and Kilroy Airport Way – Phase 2 (EO-3484) and authorize the General Manager to sign a construction contract with Toro Enterprises, Inc. in the amount of \$2,399,900.

Executive Summary

On July 15, 2021 and July 22, 2021, a notice inviting bids was published for the Large Potable Water Valve Replacement Project – Redondo Avenue and Kilroy Airport Way – Phase 2 (EO-3484) in accordance with public contract code section 22037. The work involves furnishing all labor, equipment and materials necessary to remove five (5) existing 24-inch and 30-inch gate valves, and install four (4) new butterfly valves and a new section of 30-inch steel pipe along Redondo Avenue, between Kilroy Airport Way and Willow Avenue.

On August 12, 2021, five (5) bids were received and opened. The bid tabulation is attached. After evaluating all bids received, the lowest responsive bid submitted by Toro Enterprises, Inc., in the amount of \$2,399,900 was found to be in conformance with the bid documents.

The Engineer's estimate is \$2,623,200.

Board Options/Fiscal Impacts

Adopt Specifications WD-20-21 for the Large Potable Water Valve Replacement Project – Redondo Avenue and Kilroy Airport Way – Phase 2 (EO-3484) and authorize the General Manager to sign a construction contract with Toro Enterprises, Inc. in the amount of \$2,399,900.

Fiscal Impact: The total FY 22 cost of the contract to the Water Fund will be \$2,399,900. The costs are included in the Water Fund FY 22 CIP budget.

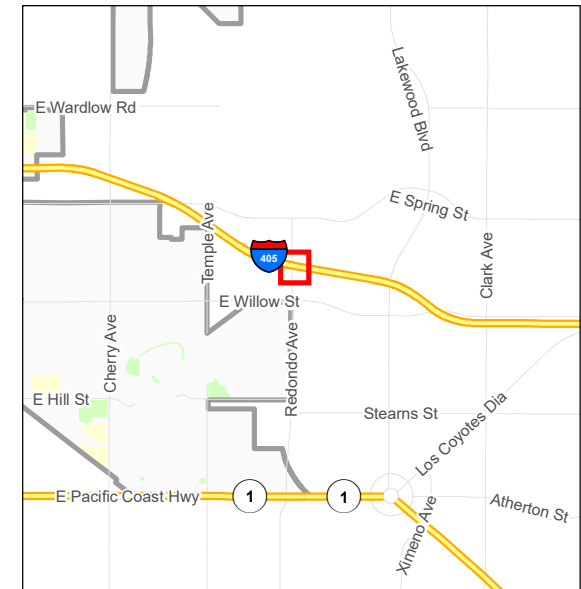
