#### Additional Terms

PAYMENT TERMS (excluding applicable taxes): 100% of the Total Due is due 15 days from the execution date of this Addendum. Commencing on November 1, 2021, and each 3 month period thereafter, Yardi shall invoice Client at a rate of 7.5% of the funds disbursed for ERA 1 for the preceding 3 month period. The fees for this Schedule A shall not exceed \$1,507,957.00.

The Rent Relief fees in this Schedule A Fee Schedule are for the approximately \$30,150,000.00 of funds initially allocated to Client, which consists of \$13,750,000.00 in federal funding for the Emergency Rental Assistance Program as part of the Consolidated Appropriation Act of 2020 (ERA 1) and \$16,400,000.00 in state funding for the Community Development Block Grant. If additional funds are allocated, then additional fees will apply as mutually agreed between the parties.
