# July 21<sup>st</sup> District 6

Agenda Attachments

- A 26-page paper from the Equitable Redistricting for the Cambodian Community asking the commission to keep the Cambodian community together. The paper includes a letter from 2018, maps, data, and a letter from Mayor Robert Garcia supporting the Cambodian community's efforts to unify into one council district.
- 2. E comment: "District 6 should center around Cambodia Town and seek to empower those families".
- 3. E comment: "Little Manila should be unified in one district." Also mentioned the West side of LB otherwise known as "Asthma Alley" and "Diesel Death Zone" should have more representation.

## Public Comments

1. Historic African American Community. Blacks have been a part of the community. Speaker mentioned redlining and real estate and that there is a higher Black population in D6.

- 2. Equity for Cambodians. Cambodian Community. Spoke on the historical division between 4 council districts 1,2,4 and 6. Believe D6 is large enough to accommodate all Cambodians.
- 3. Equity for Cambodians. Mentioned that in 2010 there was an option to put Cambodians in one district but the final districts split the community in 4. Worked to create the LB commission. Asked to not use existing boundaries and to keep Cambodian community together.
- 4. Cambodian Community. Ask to keep Cambodian community together and to not use existing boundaries.
- 5. Cambodian Community. Asks to keep Cambodian community together and to not split other groups.
- 6. Co-chair Equity for Cambodians. LB has the largest Cambodian population in the nation. They ask to be kept in one central Cambodian district. Also asks to not use the existing districts.
- 7. Consider the Filipino community when drawing districts. Also stands in solidarity with Black and Cambodian Community.
- 8. Asks to preserve culture and COIs in the redistricting process.
- 9. Cambodian Community. Asks to keep Cambodian community in one district.
- 10. Cambodian Community. Spoke that the Cambodian Community never intended to come to the US but was forced to be here to stay alive. Also asked to keep the Cambodian Community in one district.
- 11. Co-founder of LA rethinking LB. Asks to keep the Cambodian Community together and to not use the existing lines. Said if you use the existing boundaries you will end up with the same problem of dividing COIs.
- 12. Cambodian Community. Asks to keep the Cambodian Community in one district. Also said that not all districts are created and funded equally.
- Asks to keep the Cambodian Community in one district and to see the historic maps from 1986-2011
- 14. Chair Los Altos Neighborhood. Support Cambodian communities desire to remain in one district.
- 15. Resident of South Wrigley Neighborhood. Hard to hear commissioners on online platform. Communities of color have experienced redlining and long-standing inequity in the city. Would like the commissioners to look at air quality, pollution and life expectancy based on air quality.
- 16. West Side resident. Would like more amenities in the West Side of Long Beach.
- 17. Common Cause. Concerned with the legal memo and the attorney's explanation of the charter. Would like to keep communities whole and focus on what the 2020 data will tell the commission.
- Supporter of Khmer community. Would like for Cambodian population to remain together.
  Would like the commission to look at real estate maps and redlining maps.
- 19. Would like core of districts and COIs to be kept whole.
- 20. Equity for Cambodians. Address issue of commission independence as a body. The Commission shall be independent of the mayor and city council control. Preserving cores of existing districts is not in the Measure DDD charter.
- 21. LB BAR foundation. Would like to partner with the Commission.
