

#### **Frequency of Cannabis use** 2020 DHHS Cannabis & Health Assessment


#### How Frequently do you Use Cannabis or Cannabis Related Products?

- I have never used cannabis or cannabis related products (99)
- I have used cannabis or cannabis related products in the past, but don't anymore (90)
- I use cannabis or cannabis related products a few times per month (40)
- I use cannabis or cannabis related products a few times per week (30)
- I use cannabis or cannabis related products a few times per year (71)
- I use cannabis or cannabis related products daily or almost daily (76)



#### DO YOU THINK THAT ITS SAFE TO DRIVE WHILE HIGH FROM CANNABIS?





### Collaborative Partnerships

- 20,000 educational resources to licensed cannabis dispensaries
- 3,000 Educational Trivia Coasters distributed to local bars, restaurants and breweries
- Auto-related incentives: provided to those at educational workshops to remind folks that, "DUI doesn't just mean booze"

Of participants surveyed stated that secondhand smoke had drifted into their unit in the past year.






