LOS ANGELES HOMELESS SERVICES AUTHORITY

AND CITY OF LONG BEACH

RELATING TO A BRIDGE HOME

CRISIS AND BRIDGE HOUSING PROGRAM AGREEMENT

THIS AMENDMENT NUMBER ONE ("Amendment Number One") to Agreement Number 2020CBH105 ("Agreement") is entered into by and between the Los Angeles Homeless Service Authority ("LAHSA"), a joint powers authority of the City and County of Los Angeles, and City of Long Beach ("Contractor"), a State of California municipality. WHEREAS, LAHSA and Contractor now desire to amend the Agreement for the purposes of: (a) shifting funds from Bridge Housing to Crisis Housing; and (b) making such other changes as are required in connection with all of the foregoing, as detailed elsewhere in this Amendment Number One;
