

#### **Temporarily Relief of Container Stacking Limitations**

City Council Meeting - November 9, 2021



#### **Executive Order N-19-21**

- On October 20, 2021, Governor Newsom signed Executive Order N-19-21
   Distribution of goods movement supply chain a National Crisis
  - The Ports of Los Angeles and Long Beach move roughly 35% of all containers in the United States, approximately 40% of imports and 25% of exports pass through the San Pedro Bay
  - The Executive Order gives authority to address short-term storage needs to mitigate the supply and distribution chain crisis
- On October 22, 2021, the City Manager temporarily waived enforcement of current shipping container stacking and height limits for a period of 90 days



## Outdoor Storage and Activities (LBMC 21.33.150)

- Medium Industrial (IM) Zone District Regulations: outdoor storage permitted at 12 feet, subject to setback and screening requirements. Container stacking maximum height is two (2) containers high
- General Industrial (IG) Zone District Regulations: outdoor storage permitted at 15 feet, subject to setbacks and screening requirements. Containers stacking maximum height is two (2) containers high
- Port-Related Industrial (IP) Zone District Regulations: outdoor storage permitted by the Long Beach Harbor Department




# **Zoning District and Stacking Limit Map**

- Permitted by right, no zoning stacking height limit (yellow)

## **Parcels of Potential Additional Stacking**


- Potential sites for additional stacking have been identified
  - Gathered Business License data to map out 37 potential businesses in Long Beach already permitted to stack containers and encompass the following categories:
    - Transportation Facility (Fleet Facility)
    - Warehousing
    - Trucking Office
    - General Services (Container Storage)

o These locations are located within the Zoning classifications that permit stacking

- There may be unlicensed operations doing container stacking that are not included on this map
- There may be operations with a vague or inaccurate business license description that are doing container stacking that are not included on this map

## Impacts on Long Beach

- So far, no reported impacts on surrounding communities
- Specialized equipment is needed to stack higher than 2 containers, many sites may choose not to increase stacking limits
- Engaged the Port of Long Beach any impacts reported will be reviewed and determined if eligible for community mitigation program
- Port of Long Beach staff are here to answer questions about national crisis
- Staff is evaluating the efficacy of the emergency action as the 90-day limit approaches to determine next steps, and whether it can or should be extended, expanded, or ended



#### Recommendation

- Receive and file a report on container stacking and height limit regulations; and,
- Approve the City Manager's emergency action to temporarily waive enforcement of Long Beach Municipal Code, Section 21.33.150, for a period of 90 days beginning October 22, 2021, in alignment with the Governor's Executive Order. (Citywide)
