The Appellant violated sections 8.76.010K and 9.65.030 of the Long Beach Municipal Code, because on June 19, 2014, the conditions of the subject property were such that trash cans and trash and debris existed at the front of the property on the driveway. The Appeal is denied. The motion carried 5-1. Chairman Thompson abstained.
