### **2.** 18-007VA

Recommendation to discuss awareness and recognition *ad hoc* subcommittee report - Commissioners Orozco and Contreras

The subcommittee met with LBFD to explore strengthening or enhancing messaging around illegal 4th of July fireworks and their effects on Veterans with PTSD. It also met with Partners of Parks to inventory existing Veterans memorials and commemorations in Long Beach parks and to explore future possibilities. The subcommittee also discussed the Commission's participation in the renovation of the Belmont Veterans Memorial Pier, part of Mayor Garcia's 8 by 2028 initiative (eight capital improvement projects by the Summer Olympics of 2028).

The subcommittee recommended that the Commission seek partnerships with other organizations and agencies around Veteran PTSD firework awareness; strengthen its partnership with Partners of Parks; contact CD 9 and other stakeholders about the possibility of a commemorative brick program in Houghton Park, and actively participate in the renovation of the Pier.

#### **3.** 18-008VA

Recommendation to discuss economic development *ad hoc* subcommittee report - Commissioners Fernandez and Doplemore

Commissioner Fernandez indicated that the trades have a pressing need for skilled workers as the Baby Boomers retire. The trades offer training, good pay and room for advancement; they just need individuals who are willing to learn. The subcommittee conceptualized a meet and greet event as a means for linking employers in the trades with potential employees, namely, Veterans transitioning out of active duty who may be disabled or simply unaware of their career options. Fernandez has already laid the ground work for partnerships between the trades (local businesses), the VA and the VA's Veterans Rehabilitation Office (VRO).

# 8. 18-013VA Recommendation to discuss revised Annual Report document

Only one change was made to the Annual Report draft since the Commission reviewed it at the January meeting. Staff inserted the amount expended to operate the Commission for 12 months: \$59,277.06. Commissioner Smith made a motion to approve the Annual Report but later withdrew it because the Commission's approval is not required. The report will be submitted as a memo from the Health Department director to the City Manager. The Commission explored the opportunities the report affords for making recommendations to the Council as well as greater visibility for the Commission should it be allowed to present the report at a Council meeting. The Commission decided to postpone submission of the report for one month so they can add their recommendations. Commissioners are encouraged to make recommendations regardless of subject matter or which *ad hoc* subcommittee they are seated upon. These recommendations will be reviewed at the next meeting.
