# CALL TO ORDER

**1.** 18-048VA Recommendation to approve minutes for the Veterans Affairs Commission meeting on July 11, 2018.

#### PUBLIC PARTICIPATION

Jamone Pili, a Veteran, member of the City's Citizen's Advisory Commission on Disabilities (CACOD) and a manager for the Motel 6 located at 7th and PCH, across the street from the VA Long Beach, addressed the Commission. The motel provides a "home away from home" for Veterans who utilize the VA hospital and their families. Pili expressed his gratitude for this nation's active duty and Veteran service members, for members of his own extended family for their generations of service, and for the Veterans Commission for its efforts. In addition, he shared the motel's renewed commitment to hiring Veterans and their family members through its "Operation Next Step" program.

## **REGULAR AGENDA**

## CHAIR'S REPORT

Chair Orozco did not present a report. The Chair asked that the order of items be changed, with action item number 6, Strategic Plan discussion moving to the top of the agenda. There was no objection to the change.

6. 18-053VA Recommendation to discuss Strategic Plan - Ginger Lee, Bureau Manager, Collective Impact & Operations

Ginger Lee led the group in identifying agreements to help the strategic planning discussion run smoothly. The group agreed: 1) to listen with an open mind and to be respectful; to engage, ask questions and keep things positive; 2) to give proactive feedback: different points of view help to further develop ideas; 3) to be accountable by following through on a commitment to offer assistance, and, 4) to communicate effectively and often by being clear about when a response is needed or if it's not possible to respond within a specified time frame, et al.

The Commission reviewed a draft outline of the strategic plan. Discussion proceeded on the status of developing the plan. To date, planning activity has occurred on parallel tracks, one with a view towards the overall conditions and needs of Veterans in Long Beach, and the other with a focus on specific recommendations (projects). So far, Long Beach-based data has been hard to come by compared with more general data about Veterans. Uncovering and examining local data should not only be part of the strategic planning process but also inform the development of recommendations. With local data in hand, the Commission may explore the universe of possible solutions and then rethink or modify any recommendations accordingly. A brainstorming session followed with

Commissioners and staff identifying various organizations and agencies that may collect or have access to data on the local Veterans' population. Commissioners and staff agreed to contact specific organizations and report back at the next Commission meeting.

The Commission also discussed the concept of stakeholders and stakeholder interviews as part of the methodology for developing the strategic plan. Stakeholders may be defined as anyone impacted by the strategic plan's recommendations from City departments to Veterans themselves. At the next meeting, the Commission will identify stakeholders, develop interview questions and take on interview assignments.

A motion was made by Commissioner Antes, seconded by Commissioner Fernandez, to focus the Commission's efforts on uncovering local data over the next few weeks, which will, in turn, help develop recommendations for the strategic plan.

Commissioner Doplemore has reached out to Orange County Goodwill's Tierney Center for Veterans and to the Long Beach Main Library's Veterans Resource Center (VRC). Questions to consider: how might a resource like Tieney be brought to Long Beach? How can the Commission promote or otherwise support the VRC? Discussion ensued on the feasibility of creating a Commission website or expanding the current landing page to provide links to resources like Tierney and the VRC.
