- Ad Hoc Committee Report:
 - o Community Capacity Building

 - The Ad Hoc Committee met this past month and corresponded with LBCF on fundraising.
 - The Ad Hoc Committee encouraged the gathering of success stories in order to lead to effective fundraising.
 - Committee Member Howat inquired about whether organizations that were denied funding by LBCF should be considered for the Mayor's Fund.
